 - a. We are waiting for HUD to do the work to get started and we are looking at early July for an official release. Last year, We got 4 million is extra funding last year and we should be competitive for new projects this year. We just completed our strategic planning process and all new project will be in line with the plan. 1) We are looking for HMIS funding. 2) We are looking for applications for new PSH. 3) Can request of project application for additional program services for old projects. 4) We are also looking for new programs for DV bonus and HUD has expanded the definition DV.

a) Approval of Shelter Policy Standards

- a. Presented by Matt White Program Policy committee will work on and recommend standards for shelter, RRH, CI, PSH. Federal Funding require that providers adopt a standards and other national orgs are promoting standards. The program policy committee has complied all the sources and created a single document that describes all of them together HUD, Federal, and local.
- b. Some standards apply to the provider/agency. Governance and decisions board/ finance. These move down to the provider. to make the admin easier, we have organized them to agency level, provider level, and other.
- c. The proposal involves emergency shelter standards.
 - i. No significant additions to the shelter's standards.

- ii. What is the process that organization will hold the standards. OHS is the monitor agency all the standards will be append to and contract with HUD funding.
- iii. What process what used to analysis the process though REI lend.
 - 1. It was continuously used to inform the conversation.
 - 2. We also looked hiring practices.
- iv. Questions about the training requirements for 2 years and not 1 year.
 - 1. We are establishing a base line for individuals.

C) Cuyahoga Continuum Strategic Action Plan – Implementation Plan Update

We have been working to further define the action items that will support the strategy in the plan. this is not a OHS plan – this is a community plan. We need to identify a goal manager for each goal as the OHS increases. There is also a sponsor of each plan that will partner with OHS to inform and help how the implementation will happened.

We are working on an investment strategy for each goal. There are some that are not moving forward because they require additional resources. We will come back to you with further updates and we define the investment strategy.

D) Unsheltered Community Plan

Based in the County Strategic Plan there has been a group working on the extend and scope of the Unsheltered homelessness. 100-person survey. The work group is starting to build an emerging set of recommendations and expand the circle of input.

E) CoC PSH/Supportive Services Update

Angela Glassco: Frontline amendments to HUD to realign our grants to transition grants to Eden being the primary recipient. We have been exploring option to transition out of specific buildings and eden is working to identify RFQ around new providers. They are transitioning out of liberty and miles then Greenbridge 1, 2 and Winton. They are meeting with some of the RFQ and deciding who is the best to provide services on site.

F) ERA 2 Resources

EDEN is working to finalize a contract with the County to have ERA 2 for seniors and elderly and EDEN will use the funds for the CoC. We will be following up and June 1st. the funds will be available for 2 years. 10 million dollars. The guidelines will be sent out to the agencies.

Eden was recommended for the OFHA tax credit.
