- I. Welcome
- II. Call to Order (10:02 am) David Merriman, Chairman
 - i. Roll call completed; previous minutes reviewed and approved.
 - ii. Call for Review and Approval of Minutes made by David Merriman.
 - Minutes approved: Motion to approve made by Jill Smialek, seconded by Jennifer Wilson.
- III. Public Comment
 - There was no public comment.
- IV. Opening Remarks from Equity Commission Members
 - i. Jill Smialek- Public Safety and Justice Services hosted Camp Hope. It is our annual summer camp for children who have been exposed to violence. This year's camp had more diversity of cities than any other year. The kids who joined us this year ranged from victimization with child abuse and domestic violence all the way up to witnessing homicides. We had a First Responders Day. We invited police, fire, EMS to join us for the

day and hang out. We ask them to come in uniform to make it clear that they are first responder or law enforcement and so the kids can trust police and ask for help when in need. Due to the tornado, a tree fell onto one of the cabins where four of our oldest boys were sheltering. Unfortunately, there was some additional trauma exposure while we were there, but the kids did amazing. They still worked with their counselors and their therapists while they were at the camp.

- ii. Kimberley Coleman- We submitted to County Council proposed ordinance to adopt a remote work policy that would be applicable to Cuyahoga County employees who are subject to the handbook. Offering flexible work options can help us attract and retain our employees, making Cuyahoga County a desired employer of choice. The terms of the proposal will be performed in a designated alternative location outside of a county facility and it would be generally limited to no more than two days per week. Approval must be from the Director of HR and the Chief of Staff. Remote work is a management option, opposed to an employee right. We submitted the proposal to Council on July 16th, and it has been referred to the Human Resources Appointments and Equity Committee for discussion at its next meeting. Our HR team is working on a volunteerism policy for employees. We strongly encourage employees to become involved in volunteer activities that enhance and serve the communities in which we live and work. Civil Treatment Training provides methods for leaders and employees to work together to identify, prevent, and correct uncivil behavior in the workplace. Civil Treatment Training for leaders began on March 6th. As of the end of July, we had 598 county leaders that have already completed the training. HR DI committee continues to work within the organization to ensure that our employees are engaged and foster a sense of inclusion and belonging and we're very proud, this is our second year of our Can We Talk discussions. Last, we celebrated Pride Month, our next topic will be voter registration. The Can We Talk Sessions are livestreamed on the County YouTube page.
- iii. Jennifer Wilson- DEI had their 2024 Mid-Year Equity Summit, it was held virtually June 13th, it was a deeper dive into the DEI scorecard and an opportunity to get input from various departments. We had our second vendor day, that was held July 18th, various departments collaborated with us. The next vendor day will be October 18th. The upcoming training we have in September is What's Next, in October we will have Town Hall Training.
- iv. David Merriman-Thanks to everyone who supported our family fun day. We partnered with the community, gave out backpacks, assisted with our community returning to school and made a great impact. Thank you to our Fellows who assisted. We had a great time celebrating Pride. We are still assessing the impact of the Tornadoes and the disaster. Based on our assessments, there are between 25 and 50,000 SNAP recipients who lost power. The assessments continue, unfortunately the impact is disproportionately on poor communities, largely communities of color. Our Office of Re-entry had some extra funding and has extended summer employment for youth through the month of September.
- v. Jacob Bean- We are continuing our series of inviting one of our Capital Partners to share how they leverage county resources to work with MBEs. We welcomed an international delegation from countries around the world which included Azerbaijan, Brazil, Cambodia, Chile, Ecuador, Ethiopia, Georgia, Ghana, India, Malaysia, Morocco, Peru, Poland, United Republic of Tanzania, and the People's Republic of China. With that international delegation we discussed small business economics, economic development

workforce, technology, and international trade. We have continued our participation in several MBE entrepreneurial events, including Congresswoman Chantelle Brown's Small Business Expo. Our Capital Partners have assisted 660 MBEs with technical support and funding.








CILF Lending in Cuyahoga County
