(If contract amendment, please identify contract term and/or scope change)</p> <p>In August 2009, Cuyahoga County was awarded a \$5.7 million Energy Efficiency and Conservation Block Grant, (EECBG) by the U.S. Department of Energy (USDOE) through the American Recovery and Reinvestment Act, (AARA).</p> <p>In September 2009, Cuyahoga County entered into an Assistance Agreement with the USDOE to develop and implement an Energy Efficiency & Conservation Strategy (—EEC&S) under Catalog of Federal Domestic Assistance Number DEEE0000708.</p> <p>The County’s EEC&S is designed to create jobs, reduce fossil fuel emissions, reduce total energy use of eligible entities, and improve energy efficiency in the building, transportation, and other appropriate sectors. In December 2010, the BOCC approved an Interagency Agreement (Resolution No. 105130, Journal 309 dated December 2, 2010) between the Cuyahoga County Department of Development (DOD), as Grantor, and the CPC, as grant sub recipient for the term August 12, 2010 through June 30, 2015 to implement and administer the MEP and be permitted to make grants to municipalities located in the County of Cuyahoga, Ohio and eligible to participate in the MEP program.</p> <p>(The CPC is a contracting authority pursuant to Section 307.92 of the Ohio Revised Code and authorized to enter into contracts pursuant to Sections 713.22 and 713.23 of the Ohio Revised Code.) A copy of the Interagency</p> <p>Municipal Energy Program</p> <p>In September 2010, the CPC commenced the MEP with two primary objectives:</p> <ol style="list-style-type: none"> 1. Award grants to municipalities to conduct American Society of Heating, Refrigerating and Air Conditioning Engineers (ASHRAE) Standard Level II baseline energy audits of their municipally-owned buildings and facilities; to guide and assist them in decision-making regarding energy efficiency and conservation projects; and 2. Provide grant awards to municipalities that had already completed a verifiable energy audit within the last three (3) years to implement energy efficiency and conservation measures (ECMs) identified in the audits and that would yield significant cost and energy savings. 	<p>_____ Approve _____ Disapprove _____ Hold</p>

		<p>The field of energy management is a complex subject and in order to develop the most suitable program objectives, best practices, guidelines and program protocols the CPC sought through a Request for Proposal (RFP) expertise in energy management. Through the RFP process, the CPC selected and contracted with Spectrum Energy Concepts Inc.</p> <p>The CPC issued an application in 2010 to fifty-three (53) municipalities* to:</p> <ol style="list-style-type: none"> 1. Request a grant to conduct an ASHRAE (American Society of Heating, Refrigerating and Air-Conditioning Engineers) Level II energy audit of municipally-owned buildings and facilities; or 2. Implement ECM's which had been identified by a completed verifiable energy audit done within the last three (3) years. <p>*The USDOE awarded direct EECBG grants to six Cuyahoga County municipalities (Cleveland, Cleveland Heights, Euclid, Lakewood, Parma and Strongsville.</p> <p>Audit Application Evaluation and Award Determination. The amount of each municipality's grant award was determined by calculating the amount of the square footage of the city's municipally-owned buildings and facilities by an industry standard for cost per square foot rate for ASHRAE Level II Audits. Other relevant issues taken into consideration included, but were not limited to, the age, historic significance, current and future use and the most recent upgrade (s), if any, to the building or facility.</p> <p>The CPC entered into a Master Grant Agreement (MGA) with the communities:</p> <p>The MGA:</p> <ol style="list-style-type: none"> 1. Incorporates the terms and conditions of the MEP along with a customized Scope of Work for each municipality's award and reporting requirements and documentation forms; 2. Rationale Supporting the Use of the Selected Procurement Method The EECBG Program, funded by the American Recovery and Reinvestment Act (Recovery Act) of 2009, represents a Presidential priority to deploy the cheapest, cleanest, and most reliable energy technologies we have—energy efficiency and conservation—across the country. It is intended to develop, promote, implement, and manage energy efficiency and conservation projects and empower local communities to make strategic investments in energy conservation. As is the case in many areas nationwide, few Cuyahoga County municipalities have had the resources available to assess energy efficiency and make meaningful energy conservation investments. By providing grants for energy efficiency audits the majority of municipalities in Cuyahoga County have had an opportunity to conduct ASHRAE Level II grade audit of their municipally-owned buildings and facilities and have identified the most egregious energy losses that should be reversed for energy cost savings. Additionally, the information collected: 1. Has created an energy efficiency baseline; 2. Has identified a portfolio of energy conservation measures; 3. Can be used in the development of a countywide energy efficiency strategy; and</p>

		<p>4. Can be used to develop other funding opportunities to implement energy conservation measures.</p> <p>4. What other available options and/or vendors were evaluated? If none, include the reasons why. The USDOE approved the activities outlined in Cuyahoga County’s application for EECBG funds. The BOCC determined that \$3.2 million of the County’s \$5.7 million should be awarded to the fifty-three communities that did not receive a direct allocation.</p> <p>5. What ultimately lead you to this product or service? Why was the recommended vendor selected? The CPC researched EECBG funded programs and projects nationwide, and found similar programs being conducted around the Country that have elected to use a formula grant process. The CPC believes the use of formula grants in Cuyahoga County ensures that energy efficiency measures will be implemented in a majority of the county.</p> <p>6. Provide an explanation of unacceptable delays in fulfilling the County’s need that would be incurred if award was made through a competitive bid. The EECBG funds must be expended by September 38, 2012. The CPC with assistance from an energy management consulting put together a streamlined application process and using current energy efficiency standards and objectives have assisted fifty-two communities in working toward energy efficiency.</p> <p>7. The Cuyahoga County Planning Commission (CPC) was designated by the Cuyahoga County Department of Development as a sub-grant recipient of \$3.2 million to implement the Municipal Energy Program (MEP) in order to provide energy stimulus funding to the fifty-three (53) Cuyahoga County communities that did not receive direct allocation from the DOE to implement energy efficiency and conservation measures. The MEP has been designed to provide the municipalities funding to do audits of their municipally-owned buildings and facilities. Once the audits are completed, the municipalities will be allowed to apply for MEP funding for project implementation.</p> <p>The CPC issued a Request for Proposal (RFP CP-10017407) on May 19, 2010 soliciting the services of an Energy Management Consultant, Inc. The CPC received two responses and after these responses were evaluated and scored, Spectrum Energy Concepts, Inc. was selected.</p> <p>Spectrum Energy submitted a detailed bid of \$166,400.00 for to assist in development of the entire MEP. However, due to stimulus deadlines, the CPC decided to enter into a contract A contract for MEP Project Development with Spectrum Energy, Inc. for \$24,975.00 was approved by the CPC Board on August 12, 2010 and by the Board of Cuyahoga County Commissioners (BOCC) on October 14, 2010 (Resolution No. 094320). The Contract number is CE-1000695-1 Revised: 11/15/11 Shortly thereafter, three issues prompted an amendment to the original contract:</p> <ol style="list-style-type: none"> 1. The great response by the communities – 50 of the 53 communities submitted applications; 2. The audits would need to be reviewed by Spectrum Energy, Inc. for compliance with the required standard; and 3. DOE directed all grantees, which would be the Department of Development, to obligate the grant funds by March 28, 2011. Contract CE-1000695-01 was amended by the BOCC, on December 2, 2010 through Resolution RE-105188. The amendment, effective November 10, 2010, increased the contract amount by \$50,000.00 to a not-to-exceed amount of \$74,975.00 and expanded the scope of services provided by Spectrum Energy Concepts, Inc. In mid-May2011, it was determined that the contract with Spectrum Energy Concepts, Inc. needed to be amended to additional funds and to expand the scope of services. This final amendment would add \$87,500.00, for a total contract award of \$162,475.00 (close to Spectrum’s

The CPC Board approved the second amendment on July 14, 2011; however the Department of Development, as grantor, denied the CPC's request for the second amendment and instructed the CPC to issue a new Request for Proposal.</p> <p>However, due to a number of factors such as the slow pace at which the municipalities issued bid packages, the unanticipated time that was needed to address shortcomings in the submitted energy audits and First Energy Demand Side Rebate Program, led to the expenditure of the entire \$74,975.00 in contract funds, plus an additional \$27,156.20, by mid-April 2011. Although monthly invoices had been submitted by Spectrum Energy Inc. these invoices were not processed in a timely manner which resulted in the contractor continuing to work through mid-August.</p> <p>2. Rationale Supporting the Use of the Selected Procurement Method The original contract and the first amendment between the CPC and Spectrum Energy were approved by the BOCC. However, Spectrum Energy Concepts, Inc. invoices for mid-April through August were not processed timely which led to an over-expenditure on CE1000695-01 of \$27,156.20</p> <p>4. Why was the recommended vendor selected? The Cuyahoga County Planning Commission (CPC) was designated by the Cuyahoga County Department of Development as a sub-grant recipient of \$3.2 million to implement the Municipal Energy Program (MEP) in order to provide energy stimulus funding to the fifty-three (53) Cuyahoga County communities that did not receive direct allocation from the DOE to implement energy efficiency and conservation measures. Due to this experience the Director of the Cuyahoga County Development Department asked that the CPC design and implement the MEP. The CPC determined that it needed the assistance of an energy management consultant to assist in understanding the basic standards of energy and energy efficiency. The CPC reviewed the energy management associations for companies located in Cuyahoga County and it was contacted by several energy management consultants.</p> <p>The CPC issued RFP CP-10017407 on May 19, 2010 soliciting the services of an Energy Management Consultant, Inc. The CPC received two responses, Humanity’s Loom and Spectrum Energy Concepts. These responses were Revised: 11/15/11 Page 6 of 8 evaluated using the County RFP Procurement criteria and Spectrum received the higher score and negotiated a contract with Spectrum Energy Concepts, Inc.</p> <p>The CPC will solicit a new energy management consultant through a formal Request for Proposal (RFP) Process to complete the review of the municipal energy audits funded by the MEP to ensure compliance with MEP and ASHRAE; and assist the CPC in the development of Phase 2 – Evaluation and Selection of Energy Conservation Measurements.</p> <p>6. Provide an explanation of unacceptable delays in fulfilling the County’s need that would be incurred if award was made through a competitive bid?. Spectrum Energy Concepts, Inc. performed work in April, May, June and July 2010 and submitted the necessary invoices. The billing was not processed and Spectrum is due the additional funds. The only way to ensure reimbursement is to do a second amendment to the contract. Work on project development will not be done until an RFP is issued and a contractor selected.</p> <p>7. Why was the recommended vendor selected?</p> <p>The FCFC Executives wanted a continuum of service that responded to prevention needs for children birth to 18. All HMG subcontracted vendors are selected through an RFP process. - Providence House serves families who have determined they have risk factors. The families voluntarily place their children ages 0-6 at Providence House for 30-45 days to give the family time to reduce the risk factors. Providence House will use its OCTF funding to provide wraparound services to support reunited families and prevent recidivism.
