This simulates the barriers and issues reentry citizens face when navigating social service and criminal justice systems.

The simulation is a two-part workshop/training exercise to help participants understand the day to day reality of rejoining the community following incarceration.

Think Tank is based in Ohio and was the vendor selected to do this unique training by ODRC. ODRC has sponsored the reentry simulation at other events. As the Office of Reentry we wanted to partner with ODRC and sponsor this workshop here in Cuyahoga County.
