## II – REVIEW MINUTES – 5/22/17

Armond Budish motioned to approve the minutes from the May 22, 2017 meeting, as written; Mike King seconded. The minutes were unanimously approved.

Dale Miller asked if the Department was confident the scope of work can be completed under the not-to-exceed amount; and inquired about what measures the Department will take to ensure the work is finished, as it relates to a provision in the contract that states discussions are needed to determine if additional funding will be provided to complete the scope of work after a certain number of work hours have been exhausted, as there is no identifiable cost amount in the contract. Nan Baker asked due to implementation challenges will the Department have the workforce to carry out services without outside assistance once the contract expires in December. Nan also requested Council be provided with a monthly update on the status of the project so Council members can apprise constituents on the progress being made on regarding the Loan Portfolio Program. Armond commented the Director of Development and the Law Department will work jointly to put together a request for proposals to seek an outside loan servicing organization that can ensure the

servicing of the loans as opposed to the making of the loan is done professionally. Armond Budish motioned to approve; Nan Baker seconded. Item BC2017-393 was unanimously approved.

Dale Miller asked if the cost is based on the number of meetings as opposed to a fixed amount; and are income determinations conducted annually. Dale asked if it turns out that a majority of eligible employees have been served and the demand is substantially less than what the County expected, is there is a process in place to adjust the cost or is the \$25,000.00 a fixed amount. Armond inquired about the total amount of savings associated with the program. Armond Budish motioned to approve; Dale Miller seconded. Item BC2017-411 was unanimously approved.

Dale commented about the increased number offenders being monitored by the devices and asked if it was due to a lack of reduction in the Jail population or are longer sentences being given out. Mike King asked if the current number of offenders being monitored is maintained what is the annual cost for the provision of these services going forward if the contract is renewed. Armond commented that initially it was anticipated that the monitors would be utilized primarily for pre-trial detention, but there has been an increase in use of the devices post probation. Armond Budish motioned to approve; Dale Miller seconded. Item BC2017-413 was unanimously approved.
