The Cuyahoga County Division of Children and Family Services (DCFS) is currently using the Accurint product marketed by LexisNexis. The Accurint service provides specialized services for government subscribers. Accurint is mission-critical by giving DCFS the ability to quickly locate information in its diligent searches for relatives, pre-screening for criminal records, and locating persons through the features of this service. Last year Accurint was used to perform 12,551 searches. The contract on this service ends on September 30, 2017.

The current Accurint contract is for Cuyahoga County. Part of the contract is funded by DCFS and part by the Office of Child Support Services (OCSS). DCFS has 24 User ID's. The ID's are assigned through the direct services and resources departments. The users who have an ID are considered "SuperUsers" for DCFS. The can be reassigned as needed for agency needs.

Use of Accurint has resulted in more accurate information being retrieve in less time. Accurate information is vital in protecting the children and families for which DCFS is mandated to provide services. The use of Accurint supports the following county initiatives:

Provide a safety net for children, families, adults and older persons to meet their immediate, basic needs. Provide staff the data, tools and training they need to deliver results.

Prior to obtaining this service, DCFS had people spending hours using public search engines, poring through public databases, and following the links returned, many of which were useless. DCFS had no centralized method to locate this information so many pieces of information could be missed. Also, many of the public records and search links that were used are no longer free. It was labor intensive and delayed the relative identification and notification efforts. Further, the quality of the information was often questionable. If Accurint were to be removed, it would force DCFS into these previous practices.

OCSS has decided to terminate their use of the Accurint service and will use a product called CLEAR. DCFS also evaluated CLEAR and determined that it did not meet their needs as well as Accurint. While some of CLEAR's features were superior to Accurint, it failed the primary test. A list of known offenders was searched in both systems. Accurint returned the relevant information on all the offenders while CLEAR did not. Safety is primary business driver for using this product. Any labor savings are a fortunate by product of its usage.

The most viable solution for DCFS is the continued use of Accurint.

### Recommendations

Negotiate a new contract with LexisNexis to continue the Accurint service for DCFS beyond September 30, 2017.
