MOUs were developed in partnership with the Law Department to allow for other public sector agencies to join Cuyahoga County in participating in The Lab. Through these MOUs additional test environments and subject matter expertise will be made available to local entrepreneurs and business, expanding the reach and impact of The Lab and allowing the program to support a diverse cohort.
