PUBLIC WORKS, AMD 2, NORTH MAIN STREET, COOK PAVING, CE1800324

Scope of Work Summary

Department of Public Works is submitting an amended agreement (Subsidiary No. 2) to Contract CE1800324 with Cook Paving & Construction Co., Inc. for the resurfacing of North Main Street from Chagrin Falls Township SCL to Falls Road in Chagrin Falls Township for an increase amount not-to-exceed \$43,352.82.

Is recommending accepting construction as complete and in accordance with plans and specifications; requesting authority for the County Treasurer to release the escrow account, in accordance with Ohio Revised Code Section 153.63.

The plan quantity adjustments were based on actual field measurements and quantities used. Most of the additional funds (\$30,532.75) were due to a severe storm that overwhelmed two existing culverts on North Main Street and caused damage along the shoulder of the roadway. One of the structures was failing structurally and it was determined to replace the existing 18" culvert with a 24" culvert by open cutting the road.
