Brief Update: DCFS Administrator

DISCUSSION

- Cynthia Weiskittel updated the committee on County data
- 2900 kids in care; more than 3 years in relative care. 2/3 of the kids are in County
- Some kids are placed as far away as Oklahoma and Arkansas
- State is discussing paying kin to provide care for their relatives
- Cynthia Weiskittel made recommendations to pay kin to the County Council
- The CANOPY Child Advocacy Center (CAC) opened in 11/18. Since then, more than 600 children have been seen. The goal of the CAC is to improve working relationships with all systems, such as the police and to have one place families can to get all their service needs met.
- County is good with Cleveland Police Department
- Opiate money is coming 3.4 million dollars
- Use the Opiate money to restore START (serves women with positive child at birth)
- \$1 million dollars for children's board and care
- 1997 START came to Cleveland
- Laid off Advocates in 1998
- # of drug exposed babies is going up (more with opiates)
- Increased involvement with dads; nice improvement with dads at the table. Still have long way to go
- Hiring of retired officers; Need 10 officers and 2 recommended
- Shadow Box Program to expedite how workers look at different options. Conversations will help improve their critical thinking, communication, and decision making. All Investigations Staff have gone through 3 or 4 scenarios. They are teaching them not to accept what the parent says. Learn to investigate and come up with multiple hypotheses.
- Cost of Board and Care is \$60 million
- Children placed with kin, caregivers receive a small amount of cash each month if they can prove a blood relation and medical cards. Food stamps and child care are based on kinship family's income.
- Over 1/3 of the children are with their kin
- 1,073 children are in Kin placement

	ACTION ITEM: Determine Future Meeting Locations

DISCUSSION	 Increase Public Awareness Discussed a series of community meetings – Public meetings Radio ads – didn't work Direct Mail to families with open cases and to key community partners, professionals, families, Collaboratives and tell them the location We need more involvement with the community Who is coming to the meetings? Who is in the audience? Do we need to report out to the community? We need to figure out who do we want to attend the meetings Call out to community – Prevention and Intervention
	 Professionals Committees include community members Flexible awareness to draw people in; 1. Campaign and billboards; 2. Sharing stories Deonna Kirkpatrick shared the HOPE for the Holidays campaign with the committee; donate toys, money and/or adopt a family Jacqueline McCray share the Kinnect Program. Kinship Navigation Program, a local organization, awarded a grant in early Spring. Information is forth coming.

DISCUSSION	 Invest in Children – need time for them to prepare to present to the committee The committee has put Invest in Children off long enough. Do we need more information from them before they present? John is on the Board of Health's Fatality Review. Funds go through the Board of Health to Invest in Children. Rebekah Dorman felt like the committee would like to learn more about this Invest in Children wants to present more than just doing a Public Comment; they can have 20-30 minutes to present Should we have Invest in Children present in December? Child Protection Teams' role they play to increase public/people understanding Need protocols for people to present at meetings; if not, everybody will want to present – set timeframes Procedures need to be put on next agenda Limit presentation to 20 minutes Is there something the committee wants to take on?
