The meeting was called to order at 11:00 a.m.

II - REVIEW MINUTES - 10/19/2020

Leigh Tucker motioned to approve the minutes from the October 19, 2020 meeting; Nichole English seconded. The minutes were approved by unanimous vote, as written.

Tom Pavich and Nichole English, Department of Public Works, presented. Dale Miller expressed his continued concern that the County may be financially responsible for a portion of these vehicle purchases once the COVID-19 pandemic has passed. Nichole English said that all the guidance received indicates that there would be no payback required if the vehicles were in use by the end of the year and believes that the vehicles will be in use well beyond 2020; and commented that a prior discussion on this issue was referred to the Law Department for an opinion. Nan Baker relayed the same concerns expressed by Mr.

Miller and asked if the Law Department could review this issue and render an opinion prior to the purchase of the vehicles; and recommended the Board provide conditional approval pending the Law Department's findings. Jerad Zibritosky, Department of Law, stated that it is also his understanding that no reimbursement will be required once the pandemic has ended but said that he will again review the matter regarding financial responsibility for vehicle purchases and provide an opinion within 1-2 days.

At 11:08 a.m., Mr. Zibritosky commented that the live video stream of the meeting was not providing audio and requested that the meeting be paused until the technical issue could be addressed. The meeting was paused at 11:09 a.m. Trevor McAleer asked if the meeting site was updated to indicate audio issues and asked if the meeting could continue since the audio could be heard through the call-in number posted. Mr. Zibritosky said that the meeting could continue as long as the live stream video displayed the call-in number and indicated there were audio issues with the live stream. The meeting reconvened at 11:31 a.m.

Leigh Tucker motioned to conditionally approve the item; Trevor McAleer seconded. Item BC2020-577 was conditionally approved by unanimous vote.
