Alex Pellom Department of Public Safety and Justice Services and Tracey Mason, Division of Senior and Adult Services, presented. Nan Baker expressed her support of these important services and asked how the call center operations will be managed; requested follow up on the average wait time of incoming calls and outcomes of services and whether expectations were met; asked what the status of the mailer is; recommended that the mailer to be sent to seniors only contain information regarding COVID-19

vaccinations and not reference any other senior services; and asked Trevor McAleer to follow up with the Board when the mailing has been complete.

Dale Miller also expressed his support of services as the rollout of the vaccine has been slow and wants to assist at a local level; stressed the importance that call takers be well-trained as there is so much information from various sources and may be difficult for seniors to navigate to find accurate information and make appointments, especially those not comfortable with technology; and stated that this program will not work if the call takers are not well-trained.

Trevor McAleer asked what date the mailer will be sent and how many will be sent. Michael Chambers motioned to approve the item; Dale Miller seconded. Item BC2021-35 was approved by unanimous vote.

The Honorable Judge Joan Synenberg will oversee the Pro Bono Collaborative activities with the assistance of a full-time coordinator. In turn, the coordinator will work with the Legal Aid Society of Cleveland to identify local attorneys willing to volunteer their time supporting the Pro Bono Collaborative.

The Pro Bono Collaborative goal is to schedule clients every month with local *pro bono* attorneys who will assist them with their civil legal matters. The Pro Bono Collaborative will serve approximately 375 unique clients.

A *pro bono* recruitment program will target attorneys from small, medium and large firms, solo practitioners, clinic attorneys, and students from CWRU, Cleveland Marshall, and the University of Akron Law Schools. All *pro bono* attorneys will adhere to COVID-19 safety requirements when meeting with clients. All attorneys will be covered under the Legal Aid Society of Cleveland's professional liability insurance.

Every month, conditioned upon adequate space for social distancing and compliance with COVID-19 safety precautions, the Collaborative will provide complimentary Continuing Legal Education (CLE) training for *pro bono* attorneys on various civil legal issues impacting dually diagnosed and underserved members of our community.

To ensure the continued success of the Pro Bono Collaborative, the coordinator will monitor program activities to track referrals, the type of civil matters identified and addressed, the hours of *pro bono* legal services delivered, and client satisfaction.
