Nan Baker asked Michael Chambers if the challenges the department experienced in processing this item through the Infor system have been resolved and whether the process will be improved by the time these contracts are ready for renewal. Mr. Chambers indicated that the Fiscal Office has reached out to provide additional assistance to user departments to help overcome their specific challenges with the Infor system and that progress has been made. Michael Chambers motioned to approve the item; Dale Miller seconded. Item BC2021-157 was approved by unanimous vote.

Dale Miller asked how the data that is imported from the City of Lakewood's system to the County system is used. James Boyle asked if other communities are included in the data sharing services and what records are shared. Michael Chambers motioned to approve the item; James Boyle seconded. Item BC2021-159 was approved by unanimous vote.

Dale Miller asked for clarification that the expenses are for claims that are coming in under a policy that was in effect but has been superseded by a new arrangement; asked Mr. Huth why the County, rather than The MetroHealth System, is responsible for these expenses; asked for clarification on which policy is currently in place; and asked for follow up from the department regarding the last date an event would have occurred that would require coverage under the policy.

Nan Baker referred to the responses to the advanced questions and asked if any out-of-pocket expenses, such as food and travel, are covered by these funds; asked if the department anticipates any additional funding in the future to cover reimbursements; asked Mr. Huth if these additional costs were anticipated and will this matter be discussed with The MetroHealth System during the planning stages; and asked for clarification on when the employees will no longer be covered under the County policy.

Michael Chambers motioned to approve the item; James Boyle seconded. Item BC2021-161 was approved by unanimous vote.

Nan Baker asked how long the original system has been in place and if the ChildPlus Management Information System is a better system and whether it is a more costly system to operate; asked for clarification on the acronym COPA and if Starting Point is maintaining this system now; asked how far back the data is from and what enhancements can be expected in the new system that we are not getting now; asked what the anticipated outcome will be in July, 2021; and asked what the costs will be to continue using this new system after implementation is complete. Michael Chambers motioned to approve the item; Dale Miller seconded. Item BC2021-163 was approved by unanimous vote.

James Boyle asked for additional information regarding the issue with the change in insurance requirements that resulted in the delay in processing this contract; and commented that he would hope the Law Department is looking at the entire County inventory of contracts, as this case resulted in no insurance issue. Michael Chambers motioned to approve the item; Nan Baker seconded. Item BC2021-164 was approved by unanimous vote.
