Dale Miller commented that he understands the seriousness of lead paint issues in Cleveland, and also problems in the City of Lakewood and other inner ring suburbs and asked what can be done in other communities that need these services.

Nan Baker asked when the hands-on, in-home paint removal will begin to ensure safer environments or will money be used only for education, training and hotline services; asked if this organization just increases awareness on lead hazards; asked for clarification on how money will be spent over the next 5 years and if additional funding requests are anticipated; asked what percentage of the \$80 million in loans and grants will be allocated throughout Cuyahoga County and to which communities; asked what is the contribution to the program from the City of Cleveland; asked if the payment request will be going to County Council Committee for discussion; commented that rental housing is more of a business and that property owners who rent out their units should not be able to continue that business if conditions are

unsafe, as lead hazards have been known for many years and just requires testing to determine lead paint levels.

Trevor McAleer asked how much the State of Ohio has contributed to this program; asked if \$2 million of funds is only for use in the City of Cleveland or can it be used anywhere in Cuyahoga County; asked how much money will be available to communities outside of Cleveland over the next 5 years; asked for clarification on what services these funds will be used for, as the written materials received does not address actual lead removal.

Michael Chambers motioned to approve the item; Dale Miller seconded. Item BC2021-262 was approved by unanimous vote.
