I – CALL TO ORDER

The meeting was called to order at 11:00 a.m.

II - REVIEW MINUTES - 6/21/2021

Leigh Tucker motioned to approve the minutes from the June 21, 2021 meeting; Michael Dever seconded. The minutes were approved by unanimous vote, as written.

III – PUBLIC COMMENT

There was no public comment.

IV- CONTRACTS AND AWARDS

B. - New Items for Review

BC2021-305

Department of Public Works, recommending an award on RQ3953 and enter into Contract No. 1462 with Perspectus Architecture, LLC (37-10) in the amount not-to-exceed \$478,100.00 for professional design services for the Diversion Center(s).

Michael Dever and Matt Rymer, Department of Public Works, presented. Dale Miller asked for clarification on whether the recommended vendor was one of the highest rated firms in the initial evaluation process and asked how many responses to the Request for Proposals were received.

Nan Baker asked what the cost will be for Phase 2 of the project and the total project cost from ribbon cutting to opening the doors; asked what is the remaining balance in the Opioid Mitigation Fund and at what point will General Fund or other funding sources be needed; asked if the Alcohol and Drug Addiction and Mental Health Services Board is involved in the selection and design process; asked if there is any concern whether all County Council members are on board and understand the big picture of such a large project if contracts will be coming in under \$500,000.00, which will only require Board of Control approval, rather than full County Council; and would like to see future requests go to County Council for consideration rather than piecemealing through Board of Control, or at a minimum, send to the Public Safety Committee or Committee of the Whole.

Trevor McAleer said that he estimates there is \$85-90 million in operating funds to Alcohol and Drug Addiction and Mental Health Services Board to operate the temporary Diversion Center.

Leigh Tucker motioned to approve the item; Nan Baker seconded. Item BC2021-305 was approved by unanimous vote.

BC2021-306

Department of Public Works, recommending an award on Purchase Order No. 21001971 to Breckenridge Kitchen Equipment & Design (12-2) in the amount not-to-exceed \$359,183.00 for replacement kitchen equipment for the Jail II Kitchen at the Justice Center Complex.

Michael Dever and Matt Rymer, Department of Public Works and Laura Simms and Rhonda Gibson, Sheriff's Department, presented. Dale Miller asked how many known repairs are needed at the Jail I facility.

Nan Baker asked if this equipment can be transferred at a later date for use at the new jail facility; asked if equipment was replaced when other needed improvements, such as trays and laundry issues, were brought to their attention.

Trevor McAleer asked for follow up on whether the contract for the food services operations included capital funds to cover these types of expenses; asked if the capital funds replenish each year or are all the funds expended; asked for follow up on whether there is a warranty on the equipment; and asked if meals at the Justice Center will be brown-bag or prepared when transitioning to the new jail facility.

Leigh Tucker motioned to approve the item; Trevor McAleer seconded. Item BC2021-306 was approved by unanimous vote.

Jan Bayne and Paul Herdeg, Department of Development and Lee Chilcote, Legal Counsel on behalf of Ethan Karp and Manufacturing Advocacy and Growth Network, presented. Nan Baker asked what resources will still be needed from the County to achieve the goals for this project and will Manufacturing Advocacy and Growth Network (MAGNET) be back for additional funding and how much that may be; asked when we will begin to see the big picture for this project; asked if MAGNET will be coming to Economic Development Committee for an additional funding request; and congratulated Mr. Chilcote on his success so far and expressed her support for this exciting project.

Dale Miller also congratulated Mr. Chilcote for advancing this project to this point; and asked if additional assistance will be requested for operations or construction.

Trevor McAleer asked what the targeted date for the proposed economic development loan is to come before County Council and reminded Mr. Herdeg about County Council's August recess.

Leigh Tucker motioned to approve the item; Dale Miller seconded. Item BC2021-307 was approved by unanimous vote.

Leigh Tucker motioned to approve the item; Nan Baker seconded. Item BC2021-308 was approved by unanimous vote.

Scope of Work Summary

Sheriff's Department is requesting approval of a grant amendment from the Federal Emergency Management Agency (FEMA) through the Ohio Department of Public Safety, Emergency Management Agency (OEMA) for the period of 09/01/2017-5/31/2021 to extend the period to 3/31/2022.

This is the fourth amendment to the FY17 Operation Stonegarden grant. The first amendment was for additional grant funds in the amount of \$110,000.00 which increased the total award to \$215,000.00. This second amendment extended the grant period by two months to 6/30/2020, allowing the Sheriff's Department additional time to expend the funds. The third amendment extended the grant period for an additional year, ending May 31, 2021.
