Scope of Work Summary:

The Cuyahoga County Medical Examiner's Office received \$20,000 in grant award funding with no local match requirement. The Overdose Fatality Review (OFR) is in the purview of the Cuyahoga County Medical Examiner's Office (CCMEO) and is co-coordinated with the Cuyahoga County Board of Health (CCBH) through the Cuyahoga County Overdose Data to Action grant (CCOD2A) (CDC-RFA-CE19-1904) in Cuyahoga County. The Cuyahoga County Medical Examiner's Office has received this award from the U.S. Department of Justice, Bureau of Justice Assistance via the Institute for Intergovernmental Research for the Comprehensive Opioid, Stimulant, and Substance Abuse Program (COSSAP) Overdose Fatality Review Database Pilot Site Selection Project. The CCMEO and CCBH are coordinating a best practice approach to area overdose deaths through the pilot development of a standardized data metrics platform portal for federal implementation consideration. The database platform will facilitate communities in capturing key metrics to develop a framework of accountability and action to prevent overdose deaths.

The 1st Amendment to the Original Agreement period from September 15, 2020 -September 30, 2021 will be extended to the period September 30, 2021 through and including December 31, 2021. All other original contract terms and conditions remain unchanged.

The primary goals of the project are:

The Cuyahoga County Medical Examiner's Office will facilitate research and production of the database platform for use by communities in capturing key metrics to develop a framework of accountability and action to prevent overdose deaths.

The CCMEO and CCBH will coordinate a best practice approach to area overdose deaths through the pilot development of a standardized data metrics platform portal for federal implementation consideration.

The award requires creation of a final research report for submittal at a final presentation by key staff in Washington, D.C.

The CCMEO will coordinate with select research staff at the Case Western Reserve University (CWRU) who will participate in the research project for development of data metrics as a Sub-grantee.

Award includes the sole source licensure in perpetuity (1 count) of the IBM SPSS Statistics Standard v26 platform beginning in 2020 upon award receipt. The Cuyahoga County Medical Examiner presently utilizes the IBM SPSS Statistics Standard platform and required an additional license to access, input and develop data metrics by OFR select staff.

Procurement

As required, the procurement method for this project is through acceptance of a grant agreement in an amount up to \$20,000 through the U.S. Dept. of Justice (DOJ) via the Institute for Intergovernmental Research (IIR). The Grant will fund proportionate research time and effort for selected Personnel and Fringe Benefit costs; conference attendance by key staff to provide a final research report for submittal at a presentation in Washington, D.C.; select research staff at the Case Western Reserve University (CWRU) who will participate in the research project for development of data metrics as a Subgrantee; and the sole source licensure in perpetuity (1 count) of the IBM SPSS Statistics Standard v26 platform.

Contractor and Project Information

The grant funds will be used for selected personnel, fringe benefits, staff travel for attendance at one conference, sub-grantee support from the Case Western Reserve University, and the licensure of software.

Project Status and Planning

The project began on or about 9/15/2020 and now end on or about 12/31/2021 via execution of the 1st Amendment to the Original Agreement.

Funding

The project is 100% grant funded. The schedule of payments received by the County is through reimbursement requests submitted to the U.S. Department of Justice via the Institute for Intergovernmental Research (IIR).
