James Boyle concurred with Mr. Miller’s comments and said that the timing is essential; and said the County has struggled to keep grant writing in a unified, singular focus and that while this request is important, the County needs to look at an overall long-term grant writing process. Ray McDaniel, County Treasurer’s Office, presented. Nan Baker commented that it is unsettling for the need to give away promotional items to be able to draw attention to services that would benefit taxpayers; asked if this is the first time using this strategy and what has been done in the past; asked what types of items and asked for follow up on how many will be purchased; asked if these items could be shared with other County agencies at other public events. Michael Chambers said that there will be more Countywide outreach events now than over the past few years. Dale Miller said it is sometimes difficult to get the public’s attention due to competition and that outreach to encourage voluntary compliance of tax requirements is necessary. James Boyle concurred with Mr. Miller’s comments and asked how the department will assess compliance and if there was a return on the investment; and asked if the items only contain the County logo and does not contain any political advertising; and said there is a need to be innovative and stated how critical it is to garner the public’s attention. The Department of Public Work is requesting to amend a resolution which authorized factory authorized dealers to be utilized for parts, equipment, services, and repairs to ensure compliance with equipment and vehicle warranties and manufacturer safety standards. The factory authorized program also ensures equipment and vehicles will return to normal operating efficiency more quickly, reducing down time. In addition to reducing lengthy down time, diagnostic costs will be minimized and productivity and potential billable hours in communities will increase due to quicker response times with vehicles and equipment operating. What has been experienced on many occasions, repairs, parts, and services require a factory dealer to diagnose the problem before a quote can be generated. Current guidelines require three quotes, and this requires a downed vehicle or piece of equipment to be moved to three different dealers for quotes, which delays the repairs and increases the cost of the repair. This exemption will allow the department to take the vehicle or piece of equipment to the nearest “factory authorized” dealer that meets the department’s needs for the repair, parts, or services.

The primary goal of this is to extend the time period of the factory authorized program that ends 3/31/22, extending it until 12/31/22 and add additional funds in the amount of not-to-exceed \$365,000.00. This will allow Public Works to work directly with factory authorized dealers on repairing and/or obtaining factory dealer equipment and vehicles in a timely fashion.
