WHEREAS, Cuyahoga County received \$239,898,257 from the Federal Government through the American Rescue Plan Act ("ARPA"); and

WHEREAS, Cuyahoga County calculated 100% of the ARPA dollars as loss revenue under the U.S. Department of the Treasury Final Rule; and

WHEREAS, since all the ARPA dollars have been calculated as loss revenue, the ARPA dollars have been deposited in the County's General Fund; and

WHEREAS, the County Executive and County Council have authorized \$86 million of the ARPA dollars for community grants to benefit the residents of Cuyahoga County (the "ARPA Community Grant Fund"); and

WHEREAS, of the \$86 million for community grants, \$66 million have been encumbered for equal distribution to each County Council District; and

WHEREAS, the Cuyahoga County Council desires to provide funding from the District 8 ARPA Community Grant Fund in the amount of \$30,000 to the Rid-All Foundation for the Green Partnerships Veterans Training Program; and

WHEREAS, the Rid-All Foundation estimates approximately 15-20 veterans will be served annually through this award; and

WHEREAS, the Rid-All Foundation estimates approximately 3-5 permanent and temporary jobs will be created or retained through this project; and

WHEREAS, the Rid-All Foundation estimates the total cost of the project is \$40,000; and

WHEREAS, the Rid-All Foundation indicates the other funding source(s) for this project includes \$10,000 from the Rid-All Foundation in in-kind contributions; and

WHEREAS, the Rid-All Foundation is estimating the start date of the project will be November 2023 and the project will be completed by May 2024; and

WHEREAS, the Rid-All Foundation requested \$30,000 from the District 8 ARPA Community Grant Fund to complete this project; and

WHEREAS, the Cuyahoga County Council desires to provide funding in the amount of \$30,000 to the Rid-All Foundation to ensure this project is completed; and

PROJECT DESCRIPTION

REQUEST DESCRIPTION (include the project name, a description of the project, why the project is important or needed, and timeline of milestones/tracking of the project):

The Rid-All Green Partnership's Veterans Training Program

Our 5-Month Commercial Urban Agriculture Training Program is designed to help participants to manage their own farming business, while allowing them to learn on-site; actually practicing the hands-on skills needed to profitably farm in the city. This program is a series of five weekend seminars, running January through May or July through November, and takes place at Rid-All's training facilities in Cleveland, Ohio. The training facilities at Rid-All include greenhouses, high tunnel hoop houses, training gardens, aquaponics systems, large-scale vermicompost and composting, and food distribution.

Printed workshop material will be distributed for each session. Participants will be provided with a binder to keep the materials from each session. Upon completion of the entire program participants will have a complete workbook and reference material to keep for future use.

Farm Business Development - Agri-Business Startup & Growth Education Workshop Overview (Session #1)

This training consists of an intensive and focused collection of educational, professional, and business services, that are designed to increase the viability and chances of success for agriculturally based microbusinesses, with a focus upon microbusinesses owned by low and moderate income individuals. The key to achieving this is the mentorship, advice, and counsel that are provided by industry professionals.

The measurable outcomes include, but are not limited to, a) increased knowledge and confidence concerning entrepreneurship, b) the property formation of the participant's business, c) the completion of a written business plan, d) the acquisition of capital, e) the launch of business operations or growth of business operations, f) business survival for more than 12 months after launch of business operations, g) creation of at least one job, and h) generating revenue during the first 12 months.

Social Impact of Urban Agriculture Workshop Overview (Session #2)

The goal of this training session is to give the participants an overview of the social impacts that affect an urban agricultural project. An emphasis will be placed on Food Security & Food Security with instructions on how to integrate these disciplines into your local community via an urban agricultural project.

Urban Farming/Agriculture Workshop Overview (Session #3)

The goal of this module is to give the participants a comprehensive overview of the knowledge that is required to launch a successful Urban Farming/Agriculture Project. Instruction will provide in depth information concerning the integration of a) theory, b) principles, c) methods, and, d) the science of Urban Farming/Agriculture including high tunnel hoop house management.

Composting Workshop Overview (Session #4)

The goal of this training module is to give the participants a comprehensive overview of the knowledge that is required to prepare, implement, monitor and supervise an urban composting operation.

Health and Wellness (Session #5)

This session promotes healthy living choices including: Farm to Table Gardening, Food Preparation and Meal Planning. During this time the trainers will provide hands-on technical support and advice to ensure that the trainee's project are off to a good start.

IMPACT OF PROJECT:

Who will be served: Military and Non-Military Veterans. The overall outcome of the program is to offer returning veterans tanning and job skills that will allow them to return to active members of the community. These men and women have sacrificed their lives for us, and we want to ensure that they have opportunities available to them once they return home.

How many people will be served annually:

15-20 veterans. Veterans who complete the 5-Month Training will have the option of being placed at our Victory Garden Demonstration Site. At this site they can master the skills that they learned during their training. In addition to earning an income they can work toward setting up and managing their own farming project. Rid-All will offer technical support during this process and will assist in the build-out and set-up of their agricultural project.

Will low/moderate income people be served; if so how:

Yes, many of our veterans that return from service are on fixed incomes. This support will allow for participants to register for our training program and have the \$2,200 registration cost offset.

How does the project fit with the community and with other ongoing projects: This program is a part of Rid-All's larger Veterans Service Program. This includes our annual Veterans Day and Armed Forces Day Celebrations. Rid-All is also partnered with the City of Cleveland Veterans Collaborative.

If applicable, how many jobs will be created or retained (specify the number for each) and will the jobs be permanent or temporary: 3-5 permanent jobs. As Veterans return home from active duty many come home with the scars of combat, both physically and psychologically. Rid-All's Victory Garden Initiative is designed to offer training, job creation, and business development in the area of agriculture.

If applicable, what environmental issues or benefits will there be: In addition to being a source of fresh, healthy produce, gardening can ease stress, keep you limber, and even improve your mood. Finally, gardening gets you out in the fresh air and sunshine -- and it also gets your blood moving. Some research suggests that the physical activity associated with gardening can help lower the risk of developing dementia. The sights, smells, and sounds of the garden are said to promote relaxation and reduce stress.

If applicable, how does this project serve as a catalyst for future initiatives: Rid-All is working very closely with the City of Cleveland and Union Miles Development Corp. to develop housing for homeless veterans in the City of Cleveland. A 15-unit housing complex is currently in work.

Project Name:

Human Trafficking Education and Training Program for Schools

Program Overview:

Human trafficking is a pervasive and complex public health crisis that happens in every community. It happens here in Cuyahoga County. Human trafficking is hidden in plain sight and is often unreported and underrecognized. Traffickers target the most vulnerable in our community, many of them children and teens, who do not have the language to express what is happening to them or the ability to seek help. Many trafficked children still attend school, but their situation often remains hidden due to the clandestine nature of human trafficking and the fear and coercion that traffickers use to control their victims. Schools can serve as a lifeline for trafficked children. In some cases, teachers and school staff have played a critical role in identifying and helping trafficked children escape their situations. Yet, school staff needs to know how to identify a trafficking situation, how to approach a child and how to support them as necessary. Children and youth trafficked or at-risk for trafficking also need information, education, and the tools to recognize trafficking situations and to take proactive steps to prevent them.

Project Description:

To address this issue, our organization has developed a comprehensive Human Trafficking Education and Training Program that consists of the following core components:

Raise Awareness: Increase awareness of human trafficking among students, teachers, and school staff.

<u>Professional Training:</u> We will provide specialized training for school personnel (teachers, school counselors and social workers, nurses, and others) on the fundamentals of human trafficking, indicator of trafficking situations. Increase their ability to identify, assist, and support trafficking victims.

<u>Prevention:</u> Provide students with the tools to recognize potential trafficking situations and take proactive steps to prevent them.

Support: Equip teachers and school staff with the knowledge and resources to identify and respond to signs of trafficking, ensuring the safety of students.

WHEREAS, Cuyahoga County received \$239,898,257 from the Federal Government through the American Rescue Plan Act ("ARPA"); and

WHEREAS, Cuyahoga County calculated 100% of the ARPA dollars as loss revenue under the U.S. Department of the Treasury Final Rule; and

WHEREAS, since all the ARPA dollars have been calculated as loss revenue, the ARPA dollars have been deposited in the County's General Fund; and

WHEREAS, the County Executive and County Council have authorized \$86 million of the ARPA dollars for community grants to benefit the residents of Cuyahoga County (the "ARPA Community Grant Fund"); and

WHEREAS, of the \$86 million for community grants, \$66 million have been encumbered for equal distribution to each County Council District; and

WHEREAS, the Cuyahoga County Council desires to provide funding from the District 9 ARPA Community Grant Fund in the amount of \$10,000 to the Shaker Schools Foundation for the Aisha Fraser Fund; and

WHEREAS, the Shaker Schools Foundation estimates approximately 120 students will be served annually through this award; and

WHEREAS, the Shaker Schools Foundation estimates the total cost of the project is \$51,000; and

WHEREAS, the Shaker Schools Foundation indicates the other funding source(s) for this project includes funding from the Shaker School District and families with financial means; and

WHEREAS, the Shaker Schools Foundation requested \$10,000 from the District 9 ARPA Community Grant Fund to complete this project; and

WHEREAS, the Cuyahoga County Council desires to provide funding in the amount of \$10,000 to the Shaker Schools Foundation to ensure this project is completed; and

WHEREAS, this Council by a vote of at least eight (8) members determines that it is necessary that this Resolution become immediately effective in order that critical services provided by Cuyahoga County can continue to provide for the usually, daily operations of the County.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CUYAHOGA COUNTY, OHIO:

SECTION 1. That the Cuyahoga County Council hereby awards a not-toexceed amount of \$10,000 to the Shaker Schools Foundation from the General Fund made available by the American Rescue Plan Act revenue replacement provision for the Aisha Fraser Fund.

SECTION 2. If any specific appropriation is necessary to effectuate this agreement, the Director of the Office of Budget and Management is authorized to submit the requisite documentation to financial reporting to journalize the appropriation.

SECTION 3. That the County Council staff is authorized to prepare all documents to effectuate said award.

SECTION 4. That the County Executive is authorized to execute all necessary agreements and documents consistent with said award and this Resolution.

SECTION 5. If requested or necessary, the Agency of the Inspector General or Department of Internal Audit is authorized to investigate, audit, or review any part of this award.

SECTION 6. To the extent that any exemptions are necessary under the County Code and contracting procedures, they shall be deemed approved by the adoption of this Resolution.

SECTION 7. It is necessary that this Resolution become immediately effective for the usual daily operation of the County; the preservation of public peace, health or safety in the County; and any additional reasons set forth in the preamble. Provided that this Resolution receives the affirmative vote of at least eight members of Council, it shall take effect and be in force immediately upon the earliest occurrence of any of the following: (1) its approval by the County Executive through signature, (2) the expiration of the time during which it may be disapproved by the County Executive under Section 3.10(6) of the Cuyahoga County Charter, or (3) its passage by at least eight members of Council after disapproval pursuant to Section 3.10(7) of the Cuyahoga County Charter.

Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

SECTION 8. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of the Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

PROJECT DESCRIPTION

REQUEST DESCRIPTION (include the project name, a description of the project, why the project is important or needed, and timeline of milestones/tracking of the project):

The Aisha Fraser Fund, Supporting Shaker Sixth Grade Camperships and Aisha Fraser Memorial

Woodbury Elementary School is home to all of Shaker Heights City Schools 5th and 6th graders. Aisha Fraser was a beloved 6th grade teacher who made a significant impact in the lives of thousands of Woodbury students during her 15 year career. She was tragically killed in a domestic violence attack. The annual camp experience for her students was one of her passions and she wanted every student, regardless of their family's financial situation, to have the opportunity to attend.

Woodbury's 6th Grade Camp is a highlight of the Shaker School District and has been described as a right of passage in our students education and experience. The camp is designed around the International Baccalaureate (IB) philosophies, and is paired with life skills such as teamwork, communication, empathy, and problem solving, which allows students to take risks in a safe environment. Kent State and Cleveland State have researched our camp, and the results showed a positive increase in students' confidence, self esteem, risk taking, and social skills (with other students and staff) before moving on to the Middle School. Many of our 6th graders have never, and may never again, experience an outdoor camp that truly focuses on the development of the whole child. Feedback from our students has indicated how accepted, supported, and cared for they felt during the experience. Our camp is a bridge at the end of the school year that brings all of the students together before moving on to the Shaker Heights Middle School.

The coronavirus pandemic impact has been far reaching, and has gone beyond the health or economic concerns. Child-focused researchers and advocates have recognized that the virus continues to impact children and families, in terms of the social isolation, stress, anxiety, and other hardships faced. Economic hardships have also impacted their emotional and mental stress. Providing funding to our families for their students to attend camp helps them financially and helps their children to experience community and social skills.

Students with financial limitations have been able to have their camp costs covered, or partially covered, through a small campership fund. Our goal is to build that fund, in Aisha Fraser's name, to ensure that any students who want to attend the camp have the financial support needed to do that. The camp is held during the month of May and lasts two full days with an overnight experience.

Our grant would also assist with funding a memorial bench for Aisha at Woodbury Elementary School. It will be located in a quiet area outside the Sixth Grade wing where teachers, staff, parents, students and community members can reflect and honor her life and legacy. The bench will be engraved with her favorite quote, "Dance with your heart and your feet will follow." Alvin Ailey.

The timing of this initiative aligns with the fifth anniversary of her passing.

Who will be served:

Woodbury Elementary School has just over 600 students, half of which are 6th graders.

43% of Woodbury students are economically disadvantaged.

How many people will be served annually:

The initial goal is to be able to provide 6th grade camperships for any student qualified for the federal free/reduced lunch program. For Woodbury 6th graders, that is estimated as 120-125 students.

The memorial bench will serve the entire school community and the great Shaker community. Will low/moderate income people be served; if so how:

Yes, camperships are provided to students whose families don't have the financial means to cover the cost. Families are asked to contact the school if the fee for the camp (\$125 for 2022-2023) is a barrier to participation.

How does the project fit with the community and with other ongoing projects:

The Shaker Schools Foundation and School District are both committed to diversity, equity and inclusion. We work to ensure that everything we do District-wide—learning and teaching, strategic planning, hiring, professional learning, technology, operations and communications—considers diversity, equity and inclusion.

The Shaker School District provides 25% of the funding for all families and Families with financial means cover the balance of \$125. The Shaker Schools Foundation fills gaps for families that need assistance.
