CUYAHOGA COUNTY COUNCIL SPECIAL MEETING THURSDAY, OCTOBER 25, 2012 CUYAHOGA COUNTY JUSTICE CENTER COUNCIL CHAMBERS – 1ST FLOOR 9:00 AM

1. CALL TO ORDER

The meeting was called to order by Council President Connally at 9:07 a.m.

2. ROLL CALL

Council President Connally asked Clerk Schmotzer to call the roll. Councilmembers Gallagher, Schron, Conwell, Jones, Greenspan, Miller, Germana and Connally were in attendance and a quorum was determined. [Councilmembers Brady, Rogers and Simon were in attendance after Executive Session began.]
