1. CALL TO ORDER

The meeting was called to order by Council President Connally at 9:14 a.m.

2. ROLL CALL

Council President Connally asked Clerk Schmotzer to call the roll. Councilmembers Schron, Jones, Greenspan, Miller, Brady, Germana, Gallagher and Connally were in attendance and a quorum was determined. [Councilmembers Conwell and Rogers were in attendance after Executive Session began.] Councilmember Simon was absent.

3. PLEDGE OF ALLEGIANCE

The Pledge of Allegiance was recited.

4. PUBLIC COMMENT RELATED TO AGENDA

There was no public comment given related to the agenda.

5. APPROVAL OF MINUTES

- a) October 25, 2012 Special Meeting

A motion was made by Mr. Schron, seconded by Mr. Germana and approved by unanimous vote to approve the minutes of the October 25, 2012 special meeting.
