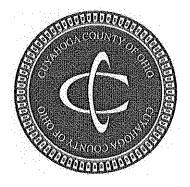

### **MINUTES** CUYAHOGA COUNTY COUNCIL REGULAR MEETING WEDNESDAY, NOVEMBER 9, 2011 CUYAHOGA COUNTY JUSTICE CENTER COUNCIL CHAMBERS – 1<sup>ST</sup> FLOOR 6:00 PM

### 1. CALL TO ORDER

The meeting was called to order by Council President Connally at 6:04 p.m.

2. ROLL CALL

## I. <u>SUBMISSION</u>

This matter came before this Fact-Finder pursuant to appointment of the State Employment Relations Board of Ohio under their case number 11-MED-04-0635. The hearings in this cause stretched over a period of some three weeks. The matter came before this Fact-Finder with forty-six unresolved issues. Forty of the issues were settled by very successful mediation. The employer's representative, according to their statement, revealed that the monetary issues could not be settled and would have to go to fact-finding hearings. There were six monetary issues and they found their way to the hearing table for final determination by the Fact-Finder. This write-up deals not only with the settled issues but also the monetary issues (six in number) that were open as a result of the mediation hearings.

,. ÷

The monetary issues were testified to by witnesses provided by the parties. The witnesses were not under oath and not sequestered nor separated. The parties were afforded the right to file a written brief at the conclusion of the testimony. It was upon the testimony, exhibits and briefs that this matter was finally determined by the Fact-Finder.

## II STATEMENT OF FACTS

As I indicated prior, forty issues were resolved by the parties and the parties are to be commended in that regard, showing a professionalism and maturity in reaching a conclusion on those issues. There remains yet six issues which were not settled, the issues being the monetary issues

which the employer stated did not fit into their budget. Each issue will be discussed as each side views them.

The first issue under consideration of this fact-finder is the issue of wages. Upon a reading of the documents filed by the union, the union is seeking an hourly wage greater than the highest hourly rate paid to correction corporals under the present collective bargaining agreement between the correction corporals and the employer. The situation as it exists now reveals that the correction corporals are earning a higher wage than the correction sergeants. This occurred because the correction sergeants were not organized by a union and received a lesser wage than the corporals who were organized. That situation, according to the union, has to be corrected.

While the employer agrees that a wage increase is necessary for the correction sergeants, the employer has not offered any substantial increase of wage for the bargaining unit herein. The record reveals that the bargaining unit herein has not received a raise in wage for a period of years, having never been certified as a bargaining unit prior. According to the union, the wage sought would bring the bargaining unit into the realm of comparison to the corporals which has not been the case before. The union's position is best stated as follows:

"<u>UNION'S POSITION</u>: The Union seeks parity with regard to wages with the Deputy Sergeant's unit. The County has not proven an inability to pay regarding wages and this unit has not seen a raise in over five years. This unit, once over twenty-eight (28) members have now been reduced to only fourteen (14) with an increase in duties and responsibilities. Lieutenants, through attrition and promotions are no longer a part of this unit and their former work load has been passed onto the Sergeants. The Union feels that since the Employer's position has been parity with regard to economic issues throughout these negotiations, there should be no reason to extend that position with regard to wages. Currently the Correction Corporals are paid over 20% rank differential above a corrections officer, the Union is asking for far less than that differential rate for the Corrections Sergeants."

The employer has offered no meaningful increase for the first year of the agreement. An hourly rate increase of thirteen plus cents per hour for the second year and an increase of fourteen plus cents per hour for the third year was offered. The union deems that inadequate. It might be noted that the increase in hours for the Sergeants has become a problem.

It is the arbitrator's view that the union's theory of a wage-rate increase is much more reasonable than the view taken by the employer in this particular matter. While the employer may argue that it has no funds for such an increase, the fact of the matter is that the union has been saddled with greater duties and less personnel, all while receiving a wage less than a subordinate is receiving under the terms of their collective bargaining agreement. The situation is not enviable. From all of this, it is recommended by the Fact-Finder that the union herein names a 6.00% increase for each of the three years of this agreement beginning with the date herein stated.

The next issue that must be considered is that of longevity. The union request for longevity reveals the following:

### "Article 18. LONGEVITY

**SECTION 18.1** All Employees who have five (5) years of continuous, uninterrupted service with the Department shall be paid a longevity allowance of three hundred seventy-five dollars (375.00). Longevity will be included in the pay for the pay period in which the anniversary date occurs. The Employee shall also be paid the amount of seventy-five dollars (575.00) for each year of full continuous service after the initial five (5) years and is to be added to the original amount set for the five (5) year period. The said amounts, previously covered, shall be paid every year until the Employee retires. On the year of retirement, said fees shall be paid but include the full years and prorate months of service or seventy-five dollars (575.00) divided by twelve months = x dollars times number of months of service."

The offer of longevity by the employer reveals the following:

### "Article 18. LONGEVITY

<u>SECTION 1.</u> Employees in the bargaining unit shall receive longevity payment for their years of service with the Sheriff's Office in accordance with the following:

1) After five (5) years of continuous service, a longevity payment of one hundred twenty-five dollars (\$125.00) per year;

2) For each additional year of service beyond five (5) years, an additional twenty-five dollars (\$25.00) shall be paid per year."

The wage increase is an important part of the contract of collective bargaining and that must be taken into consideration first when longevity is considered. As a result, I am more inclined to agree with the offer of the employer as part of my finding provided the wages are raised as recommended because the request of the union appears to be too great to be afforded for the bargaining unit in light of the wage increase sought and favored by the Fact-Finder. In other words, taking into account the wages and longevity, the Fact-Finder is of the opinion that the wages indicated should be adopted and the longevity payments sought by the employer should be adopted.

This Fact-Finder then considered group insurance. The group insurance sought by the union seeks parity between the deputy sergeants' and the correction corporals' benefits and language with regard to group insurance for the correction sergeants' unit. As everyone understands, deputy sergeants are a different classification than the correction sergeants but the union now seeks parity in group insurance between the correction sergeants and the deputy sergeants. That reasoning is not faulty. The group insurance plan offered by the employer reveals the following:

## "Article 21: GROUP INSURANCE

SECTION 1. An eligible employee is defined as a full time employee covered by this Agreement. The Flex Count Plan (the plan) is defined as the section 125 or cafeteria plan, which is provided by the Employer for health insurance, benefits for county employees. The Employer shall provide eligible employees the opportunity to enroll in the plan once during each plan year at its annual open enrollment period. The plan year commences on January 1, and ends on December 31 of the calendar year, but is subject to change.

<u>SECTION 2.</u> Effective January 1, 2012, bi-weekly employee contributions for medical and prescription drug benefits shall be determined as follows:

#### a) <u>STANDARD BENEFIT PLANS</u>

Tthe(sic) biweekly health insurance contribution rates shall be as follows:

1) Effective January 1, 2011: no change;

2) Effective January 1, 2012: employer 90% of plan costs; employee 10% of plan costs;

3) Effective January 1, 2013: employer 90% of plan costs; employee 10% of plan costs; and

4) Effective January 1, 2014: employer 90% of plan costs; employee 10% of plan costs.

#### b) METROHEALTH PLAN

The County shall offer a plan through MetroHealth at no cost to employees.

SECTION 3. The costs of the medical and prescription drug plans will be determined through an actuarially certified process that is verified through an outside party and that includes reserves necessary to sustain the plans. In successive plan years, the Employer may add to or delete plans/providers offered and/or employees may be offered additional plans with reduced or increased benefit levels.

<u>SECTION 4.</u> The Employer shall be entitled to increase the cost containment features of the Flex Count plans which may include, but are not limited to, deductibles, co-insurance, and spousal exclusion provisions.

<u>SECTION 5.</u> The Employer may implement or discontinue incentives for employees to participate in Employer sponsored wellness programs, including, but not limited to, the right to offer the opportunity to reduce employee contributions through participation in wellness programs as determined by the employer.

SECTION 6. The Employer may offer incentives to encourage use of low cost providers/plans (including HSA plans) which may be discontinued or modified by the Employer in future plans years with notification to the Union.

SECTION 7. A waiting period of no more than one hundred twenty (120) calendar days may be required before new employees are eligible to receive health and/or other insurance benefits. During the waiting period,

the Employer may require employees who desire coverage to purchase it through a third-party vendor instead of participating in the County plans that are offered to regular full-time employees. New employees shall be eligible to participate in the County plans on the first date of the first month following completion of the waiting period."

The parity sought with the deputy sergeants' program and the correction corporal's program is right on point and deserves consideration. It appears that the professional workload accomplished by the bargaining unit herein is appreciated and must be given the same understanding that the employer has given the correction corporals and deputy sergeants. There is no reason to change the plan from the parity sought and it is my belief that is the correct way of handling this matter.

As to the points concerning an employee with no sick time and hospitalization during layoff, the employer offers no answers to those issues raised by the union. The union is seeking benefit under each of those categories but the employer flat out says that it has no funds to fund those programs. The Fact Finder agrees with the employer.

The last issue is the duration of the agreement. The Fact-Finder rules that the date of this Award shall be the effective date of the contract herein. Failure to sign off by that date creates a starting date for a three-year contract to go into effect. I am not, because of this ruling, allowing any retroactivity to be paid by the employer to the union for any time prior to the effective date of this agreement.

The parties know their positions. The Fact-Finder's report is no doubt doomed as several others have been by the powers that be. However, of the 31 bargaining units, there will be some conciliator's report that will agree with the findings herein and perhaps order the wages and other items as reflected in this Award.

Based upon all of the rulings herein, the above writings form the Award of the Fact-Finder. The agreed-to article shall be the basis for the contract herein. Despite the shortfall of over thirty-six million dollars, the County is obligated to pay the wage increase requested by the union. Having a subordinate earn more money than the higher-ranked officer is an occurrence that cannot be tolerated.

The signed-off agreement of the forty settled issues shall become effective the date of this Award.
