

MINUTES CUYAHOGA COUNTY HUMAN RESOURCES, APPOINTMENTS & EQUITY COMMITTEE MEETING TUESDAY, APRIL 2, 2013 CUYAHOGA COUNTY JUSTICE CENTER COUNCIL CHAMBERS – 1ST FLOOR 10:00 AM

1. CALL TO ORDER

Chairwoman Conwell called the meeting to order at 10:12 a.m.

2. ROLL CALL

Ms. Conwell asked Deputy Clerk Muller to call the roll. Committee members Conwell, Rogers, Gallagher, Germana and Simon were in attendance and a quorum was determined.

3. PUBLIC COMMENT RELATED TO THE AGENDA

No public comments related to the agenda were given.

4. APPROVAL OF MINUTES FROM THE MARCH 19, 2013 MEETING

A motion was made by Mr. Rogers, seconded by Mr. Gallagher and approved by unanimous vote to approve the minutes of the March 19, 2013 meeting.

Mr. Jim Boyle, Special Assistant to County Executive FitzGerald, and Mr. Tony Coyne, Chair of the Group Plan Commission, addressed the Committee regarding Motion No. M2013-0012. Discussion ensued.

Mr. David Gilbert, Mr. Christopher Ronayne and Mr. Jeffrey Appelbaum addressed the Committee regarding their nominations to serve on the Group Plan Commission. Discussion ensued.
