

## MINUTES

CUYAHOGA COUNTY COUNCIL OPERATIONS & INTERGOVERNMENTAL RELATIONS COMMITTEE MEETING MONDAY, AUGUST 25, 2014 CUYAHOGA COUNTY ADMINISTRATIVE HEADQUARTERS COUNCIL CHAMBERS – 4<sup>TH</sup> FLOOR 9:00 AM

1. CALL TO ORDER

Chairman Greenspan called the meeting to order at 9:05 a.m.

2. ROLL CALL

Mr. Greenspan asked Deputy Clerk Carter to call the roll. Committee members Greenspan, Miller, Brady, Connally and Gallagher were in attendance and a quorum was determined. Councilmembers Conwell and Hairston were also in attendance.

3. PUBLIC COMMENT RELATED TO THE AGENDA

No public comments were given.

4. APPROVAL OF MINUTES FROM THE MAY 19, 2014 MEETING

A motion was made by Ms. Connally, seconded by Mr. Greenspan and approved by unanimous vote to approve the minutes of the May 19, 2014 meeting.

- 5. MATTERS REFERRED TO COMMITTEE
  - a) <u>O2014-0016</u>: An Ordinance amending Section 106.06 of the Cuyahoga County Code to establish copying costs for public records.

Mr. Miller addressed the Committee regarding Ordinance No. O2014-0016. Discussion ensued.

On a motion by Mr. Miller with a second by Mr. Greenspan, Ordinance No. O2014-0016 was considered and approved by unanimous vote to be referred to the full Council agenda for second reading.

b) <u>O2014-0022</u>: An Ordinance enacting the County Executive Transition Act, and declaring the necessity that this Ordinance become immediately effective.

Mr. Brady introduced a proposed substitute to Ordinance No. O2014-0022. Discussion ensued.

Mr. Trevor McAleer, Legislative Budget Advisor, and Mr. Michael King, Special Counsel, addressed the Committee regarding Ordinance No. O2014-0022. Discussion ensued.

Committee members and Councilmembers asked questions of Mr. McAleer and Mr. King pertaining to the item, which they answered accordingly.

A motion was then made by Ms. Connally, seconded by Mr. Gallagher and approved by unanimous vote to accept the proposed substitute.
