## 1. CALL TO ORDER

Chairwoman Conwell called the meeting to order at 10:01 a.m.

## 2. ROLL CALL

4. APPROVAL OF MINUTES FROM THE JANUARY 20, 2015 MEETING

A motion was made by Mr. Germana, seconded by Mr. Miller and approved by unanimous vote to approve the minutes of the January 20, 2015 meeting.

5. MATTERS REFERRED TO COMMITTEE

a) R2015-0031: A Resolution making an award on RQ32491 to ReliaStar Life Insurance Company dba Voya Financial, Inc. in the amount not-to-exceed \$2,485,909.00 for stop loss insurance services for County employees and their eligible dependents for the period 1/1/2015 - 12/31/2015; authorizing the County Executive to execute the contract and all other documents consistent with said award and this Resolution; and declaring the necessity that this Resolution become immediately effective.

Ms. Lisa Durkin, Interim Director of Human Resources and Ms. Sybil Haney, Budget Management Analyst, addressed the Committee regarding Resolution No. R2015-0031. Discussion ensued.

Committee members and Councilmembers asked questions of Ms. Durkin and Ms. Haney pertaining to the item, which they answered accordingly.
