1. CALL TO ORDER

Chairman Miller called the meeting to order at 3:07 p.m.

2. ROLL CALL

Mr. Miller asked Assistant Deputy Clerk Culek to call the roll. Committee members Miller, Simon and Brady were in attendance and a quorum was determined. Committee members Germana and Greenspan were absent from the meeting.

3. PUBLIC COMMENT RELATED TO THE AGENDA

4. APPROVAL OF MINUTES FROM THE FEBRUARY 17, 2015 MEETING

A motion was made by Ms. Simon, seconded by Mr. Brady and approved by unanimous vote to approve the minutes of the February 17, 2015 meeting.

- 5. MATTERS REFERRED TO COMMITTEE
  - a) <u>O2015-0004:</u> An Ordinance establishing the process by which county officers or employees serving on public bodies may designate alternates to serve in their stead, and declaring the necessity that this Ordinance become immediately effective.

Mr. Michael King, Special Counsel, addressed the Committee regarding Ordinance No. O2015-0004. Discussion ensued.

Committee members asked questions of Mr. King pertaining to the item, which he answered accordingly.

Mr. Miller introduced a proposed substitute to Ordinance No. O2015-0004. Discussion ensued.

b) <u>O2015-0005:</u> An Ordinance enacting Section 206.12 of the Cuyahoga County Code to specify the County's representation on the Cuyahoga County Planning Commission, and declaring the necessity that this Ordinance become immediately effective.
