1. CALL TO ORDER

Chairman Gallagher called the meeting to order at 1:06 p.m.

2. ROLL CALL

Mr. Gallagher asked Deputy Clerk Carter to call the roll. Committee members Gallagher, Greenspan, Germana and Conwell were in attendance and a quorum was determined. Committee member Hairston entered the meeting after the roll call was taken. Councilmembers Simon and Miller were also in attendance.

3. PUBLIC COMMENT RELATED TO THE AGENDA

6. MISCELLANEOUS BUSINESS

a) Update regarding Cuyahoga County Fairgrounds

Mr. Frank Bova, Chief Community Protection and Safety Officer; and Mr. Clifford Pinkney, Sheriff, addressed the Committee regarding animal abuse allegations at the Cuyahoga County Fairgrounds. Discussion ensued.

Committee members and Councilmembers asked questions of Mr. Bova and Sheriff Pinkney pertaining to the item, which they answered accordingly.

Mr. Timothy Fowler, President of the Cuyahoga County Agricultural Society Board, provided the Committee with information relating to the mission of the Board, the history and operation Cuyahoga County Fair and the actions taken regarding the animal abuse allegations. Discussion ensued.

Committee members and Councilmembers asked questions of Mr. Fowler pertaining to the item, which he answered accordingly.

b) Update regarding Cuyahoga County Opiate Task Force

Dr. Thomas Gilson, Medical Examiner; and Mr. Vince Caraffi, Supervisor at the Cuyahoga County Board of Health, addressed the Committee regarding the Opiate Task Force and provided information relating to the number of heroin related deaths, ages and locations of victims and physician prescription guidelines. Discussion ensued.

Committee members and Councilmembers asked questions of Dr. Gilson and Mr. Caraffi pertaining to the item, which they answered accordingly.

c) Discussion regarding Automated External Defibrillator's (AED) devices

Sheriff Pinkney and Mr. Otilio Morales, Facilities Superintendent, addressed the Committee regarding Code regulations and the locations of the County's Automated External Defibrillator (AED) devices. Discussion ensued.

Committee members and Councilmembers asked questions of Sheriff Pinkney and Mr. Morales pertaining to the item, which they answered accordingly.

d) Discussion regarding proposed legislation for mandatory CPR classes

Sheriff Pinkney addressed the Committee regarding H.B. 580 and current CPR classes offered by the Sheriff's Department. Discussion ensued.

e) Update regarding Cuyahoga Emergency Communication System and Emergency Operations Center

Mr. George Taylor, Director of the Department of Public Safety and Justice Services; and Ms. Brandy Carney, Administrator of the Department of Public Safety and Justice Services, addressed the Committee regarding timeline and completion date for the Cuyahoga Emergency Communication System and Emergency Operations Center. Discussion ensued.

f) Update regarding 9-1-1 PSAP Consolidation

Ms. Carney and Mr. Edward Kraus, Director of the Department of Regional Collaboration, addressed the Committee regarding the 9-1-1 Consolidation Plan, current number of dispatch centers and communities involved relating to 9-1-1 PSAP Consolidation. Discussion ensued.

g) Update regarding City of Euclid Jail facility

Chief Bova and Sheriff Pinkney addressed the Committee regarding the capacity, construction, costs and number of prisoners relating to the City of Euclid Jail facility. Discussion ensued.

WHEREAS, County Executive Budish/County Sheriff recommended authorizing a contract with Taser International, Inc. in the amount not-to-exceed \$724,621.43 for Taser body cameras for the period 7/1/2016 - 6/30/2021; and

WHEREAS, the primary goal of this project is to equip the Cuyahoga County Deputies with 150 Taser Axon Body Cameras in order to allow agencies to manage and share digital evidence without local storage infrastructure or software; and

WHEREAS, this project is funded as follows: (a) \$424,621.43 or 59% with funds from the General Fund; (b) \$200,000.00 or 27% with funds from the Cuyahoga County Prosecutor's Office; and (c) \$100,000.00 or 14% with the FY 15 JAG Grant funds; and

WHEREAS, it is necessary that this Resolution become immediately effective in order that critical services provided by Cuyahoga County can continue and to provide for the usual, daily operations of a County entity.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CUYAHOGA COUNTY, OHIO:

SECTION 1. That the Cuyahoga County Council hereby authorizes a contract with Taser International, Inc. in the amount not-to-exceed \$724,621.43 for Taser body cameras for the period 7/1/2016 - 6/30/2021.

SECTION 2. That the County Executive is authorized to execute the contract and all other documents consistent with this Resolution.

SECTION 3. It is necessary that this Resolution become immediately effective for the usual daily operation of the County; the preservation of public peace, health,

or safety in the County; and any additional reasons set forth in the preamble. Provided that this Resolution receives the affirmative vote of at least eight members of Council, it shall take effect and be in force immediately upon the earliest occurrence of any of the following: (1) its approval by the County Executive through signature, (2) the expiration of the time during which it may be disapproved by the County Executive under Section 3.10(6) of the Cuyahoga County Charter, or (3) its passage by at least eight members of Council after disapproval pursuant to Section 3.10(7) of the Cuyahoga County Charter. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

SECTION 4. It is found and determined that all formal actions of this Council relating to the adoption of this Resolution were adopted in an open meeting of the Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
