Meeting Minutes - Pending Committee Approval

1. CALL TO ORDER

The meeting was called to order by Chairman Schron at 2:08pm. A quorum was determined.

2. ROLL CALL

Committee members present: Schron, Brady, Rogers, Gallagher, Germana, Greenspan; Connally. Also in attendance are Council Member Miller & Bob Ivory and Nate Kelly from the Executive's Office.

3. PUBLIC COMMENT RELATED TO THE AGENDA No public comment related to the agenda.

4. OPEN ISSUES

- a) PRESENTATION BY JEFF APPELBAUM FROM THOMPSON HINE REGARDING CONSTRUCTION ALTERNATIVES FOR ECONOMIC DEVELOPMENT.

 Jeff Appelbaum continued his presentation re: design / build, and bridging (a design / build alternative) to the committee, and also addressed the committee new issues that have arisen since their last meeting including changes as it relates to the new State Budget. A question and answer session occurred between Mr. Appelbaum, the committee members, and non-committee Council Members.
- b) PRESENTATION BY ROBERT STRICKLAND FROM PCS, INC. REGARDING CONSTRUCTION ALTERNATIVES FOR ECONOMIC DEVELOPMENT.

 Robert Strickland presented his credentials and construction alternatives including to the committee including the "A3" method and design / build. Notably the design / build method and the efficiency that this method brings. He also reviewed the advantages and disadvantages of design / build. A question and answer session occurred between Mr. Strickland, the committee members, and non-committee Council Members.

c) PRESENTATION BY DOMINIC OZANNE FROM OZANNE CONSTRUCTION REGARDING CONSTRUCTION ALTERNATIVES FOR ECONOMIC DEVELOPMENT. Dominic Ozanne addressed the committee as to how to change the culture of the procurement process and change to a more effective method moving forward, and also how to effectively communicate and satisfy all the various entities involved in the current and new methodology. He discussed four recommendations (employment policy, a small business enterprise, a design procurement system, and an ethics policy). A question and answer session occurred between Mr. Ozanne, the committee members, and non-committee Council Members. At the request of Mr. Ozanne, Mr. Appelbaum made a comment regarding job order contracting. All three presenters collectively agreed that a new methodology would be beneficial to the county.
