



1. CALL TO ORDER

The meeting was called to order by Chairman Rogers at 1:04 p.m.

2. ROLL CALL

The Clerk called the roll. Committee members Rogers, Simon and Germana were in attendance and a quorum was determined.

 - a) R2011-0238: A Resolution authorizing the County Executive to enter into an agreement with City of Cleveland Heights in the amount not-to-exceed \$512,500.00 for lead hazard remediation for the period 7/1/2011 7/31/2014, and declaring the necessity that this Resolution become immediately effective.

Paul Herdeg, Department of Development Housing Division Manager, and John Sobolewski, Board of Health Division of Community Health Supervisor, addressed the Committee regarding the funding, purpose and process of the lead hazard remediation project referenced in Resolution No. 2011-0238.
