CUYAHOGA COUNTY FINANCE & BUDGETING COMMITTEE MEETING WEDNESDAY, JULY 13, 2011 CUYAHOGA COUNTY JUSTICE CENTER COUNCIL CHAMBERS – 1ST FLOOR 10:00 AM

1. CALL TO ORDER

Chair Miller called the meeting to order at 10:04 a.m.
