- II. **Roll Call** Members Present: Dan Brady, Yvonne Conwell, Mike Gallagher, Pernel Jones; Sunny Simon arrived at 1:25 pm
- III. **Public Comment** Joyce McFolley, a current resident of the women's shelter on Payne Avenue addressed her concerns about the women's shelter.

## IV. Presentations

- a. **Office of Homeless Services** Ruth Gillett, Manager discussed the goals of the office and the Housing First Initiative, noting the efforts made through the years to create facility-based care management; to re-house people, diverting those out of the shelter system as rapidly as possible, directing them to appropriate housing options.
- b. Tapestry System of Care Catherine Lester, Director explained the history of Tapestry; the county received a 6 year federal SAMHSA grant in 2003 to address the mental health needs of 240 children who were multi-system involved; county added levy funds and other system funds to serve an additional 1000 children referred from DCFS and Juvenile Court; majority of children have significant mental health issues; Tapestry purchases care coordination, family advocacy and support, and wraparound services for children and families; system is data driven with ongoing evaluation.

a. **R2011 -0021** – A resolution authorizing the County Executive to enter into a contract with Cleveland Foodbank, Inc. in the amount not-to-exceed \$272,500.00 for emergency food purchase and distribution to Cuyahoga County hunger centers and food pantries serving residents in need for the period 1/1/2011-3/31/2011.
