Rick Werner, HHS Director presented on this contract, which provides funding to assess individuals on background issues and vocational aptitude; this is an extension of a contract to do initial assessments to prepare individuals for referral to actual training programs; funded through TANF, federal pass-through dollars. **Upon motion, duly made and seconded, R2011-0184 was unanimously recommended for passage by Council on second reading under suspension of the rules.**

- VI. Presentation Cuyahoga County Board of Developmental Disabilities, Terrence (Terry) Ryan, Ph.D., Superintendent reported on the DD Board's mission, history, programs and services, family involvement, community partners, board composition, and funding sources. The Board of DD has its own levy. Any new or additional levies on the ballot would have to be approved by Council.
- VII. Miscellaneous Business and Other Public Comment:
 - **a.** Patricia Otter of the United Cerebral Palsy Association commented on the good partnership her agency and others have with the Board of Developmental Disabilities.
 - **b.** Karen Sklodowski parent of an adult receiving DD services, expressed her appreciation for the board's efforts on her son's behalf
 - **c.** Judy Greenspan parent of an adult who previously received DD services, expressed several concerns about the DD Board and its services, particularly for those with autism.
 - **d.** Rick Werner of HHS noted that he will be updating the committee about the Mt. Pleasant situation. The county must notify the Mt. Pleasant Corporation by May 30 if we intend to continue the lease under the same or similar terms. The lease runs through November 2011.
