1. CALL TO ORDER

Mr. Chuck Corea, In-House Counsel for the Cuyahoga County Board of Developmental Disabilities (BODD); Mr. David Visocky, Chief Financial Officer of BODD; Mr. Majeed Makhlouf, Director of Law and Bonnie Teeuwen, Director of Public Works, addressed the Committee regarding Resolution No. R2011-0334. Discussion ensued.

Pleasant NOW Development Corporation for lease of office space for use by the Cuyahoga Health & Nutrition and Cuyahoga Work & Training Agencies and the Department of Children & Family Services for additional funds in the amount of \$700,000.00, by changing the time period from 10/1/2000 - 9/30/2010 to 10/1/2000 - 11/30/2011; and declaring the necessity that this Resolution become immediately effective.

WHEREAS, County Executive FitzGerald/ Department of Health and Human Services/ Division of Community Initiatives has submitted a request to contract with Emerald Development and Economic Network, Inc. (EDEN, Inc.) in the amount not-to-exceed \$605,412.00 for the Shelter Plus Care Sponsor-based Rental Assistance Program in connection with the FY2010 Continuum of Care Homeless Assistance Grant Programs and the McKinney-Vento Homeless Assistance Act for the period of 8/1/2011 - 7/31/2012; and,

WHEREAS, Shelter Plus Care Program is a sponsor-based rental assistance program for formerly homeless persons with disabilities; and,

WHEREAS, EDEN, Inc. is located at 7812 Madison Avenue, Cleveland, Ohio 44102, and is located in County Council District #3; and,

WHEREAS, the Executive Director is Kathy Kazol at the not for profit EDEN, Inc.; and,

WHEREAS, the primary goals for the Shelter Plus Care Rental Assistance Program are a) mail rent subsidy checks to landlords on time; b) approve applications for homeless persons with disabilities which are submitted by behavioral health system case workers; and c) conduct Housing Quality Standards inspections before participants move into units; and,

WHEREAS, over one hundred households receive an ongoing subsidy through the Shelter Plus Care; and,

WHEREAS, this proposed Contract received an RFP Exemption on 11/21/11 from the Contracts and Purchasing Board; and,

WHEREAS, the United States Department of Housing and Urban Development awards Shelter Plus Care grants initially for a five year term that are renewed annually after the first five year period though the annual McKinney-Vento Homeless Assistance Grant; and,

WHEREAS, this contract is funded 100% by the United States Department of Housing and Urban Development, McKinney-Vento Homeless Assistance Grant; and,

WHEREAS, it is necessary that this Resolution become immediately effective in order that critical services provided by Cuyahoga County can continue and to provide for the usual, daily operation of a county department.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CUYAHOGA COUNTY, OHIO:

WHEREAS, County Executive FitzGerald/Department of Health and Human Services/Division of Community Initiatives has submitted a request to contract with MHS, Inc. in the amount not-to-exceed \$600,000.00 for the North Point Transitional Housing for Men Program for the period 10/1/2011 - 3/31/2012; and,

WHEREAS, North Point is an ongoing project within the Continuum of Care strategy to reduce homelessness for the single male population; and,

WHEREAS, this organization started in FY 2008 through a partnership with the City of Cleveland, which purchased the building in which the project is located; and,

WHEREAS, North Point Transitional Housing for Men Program is located at 1550 Superior Avenue, Cleveland, Ohio 44114, and is located in County Council District #7; and,

WHEREAS, the Executive Director is Susan Neth at the not for profit, MHS, Inc; and,

WHEREAS, the primary goals for the North Point Transitional Housing for Men Program are a) in a twelve (12) month period, to provide short term transitional housing to 320 homeless men, regardless of their sobriety, work history, age or length of homelessness; b) to assist clients to secure full time employment; and c) to assist clients to move on to permanent housing; and,

WHEREAS, this proposed Contract received exemption from the RFP process; and,

WHEREAS, the funding for this project comes from the general fund and Health and Human Services Levy dollars; and,

WHEREAS, it is necessary that this Resolution become immediately effective in order that critical services provided by Cuyahoga County can continue and to provide for the usual, daily operation of a county department.
