1. CALL TO ORDER

Chairman Gallagher called the meeting to order at 11:01 a.m.

2. ROLL CALL

Mr. Gallagher asked Assistant Deputy Clerk Thurman to call the roll. Committee members Gallagher and Greenspan were in attendance and a quorum was determined. Committee member Simon entered the meeting shortly after the roll call was taken. Councilmembers Miller and Rogers were also in attendance.

4. APPROVAL OF MINUTES FROM THE MAY 15, 2012 MEETING

6. MISCELLANEOUS BUSINESS

- a) Report from the Medical Examiner's Office

Dr. Thomas Gilson, Medical Examiner, addressed the Committee regarding initiatives undertaken by the Medical Examiner's Office. Discussion ensued.
