TESTIMONY PROVIDED BEFORE THE CUYAHOGA COUNTY COUNCIL September 25, 2012

Madame President and Members of Council:

My name is Ryan Martin and I am president of the Northern Ohio Chapter of Associated Builders and Contractors. In Cuyahoga County, ABC members number 40 construction firms, which employ over 1400 men and women, generate \$240 million in annual revenue, and have a payroll of more than \$60 million.

As you know from my correspondence with each of you, over the last several weeks since the PLA was imposed by the County Executive I have spent that time responding to claims concerning the project, ABC, its member companies, and the men and women that work for these companies.

Because I have responded in depth I won't belabor these issues, but to summarize: It's been said ABC doesn't train, but ABC is registered by the US Department of Labor and the Ohio State Apprenticeship Council to train in 18 different trades.

Just this week, it was reported that the reason why this year's PLA bid came in at \$1 million more than last year's non-PLA bid is because \$250,000 was added to the scope of the project and because of construction-related inflation over the last year.

Even though this year's project estimate actually went down by \$73,000, let's assume the reasons for the increase are true. According to the Bureau of Labor Statistics, the cost of construction has gone up .7% since last year. Even after accounting for the scope and inflation this year's bid is still more than \$780,000 more than last year's without the PLA.

It was said recently that using union labor would insure quality. This is perhaps the most specious claim I've heard. As we know, non-union firms can bid on and even work on a project with a PLA; if only they sign away their freedom to choose not to belong to a union.

Let's assume a non-union firm agrees to this; By this logic, at Noon they lack quality, at 12:01 after accepting the PLA they are suddenly a quality contractor simply by doing something they learned to do in first grade: sign their name.

And now, some would have you believe that this project, years in the making, just can't afford the delay that would be caused by rebidding it without the PLA. That this project is simply too important.

Was this project too important when the Executive put it on hold for four months to negotiate a PLA without any public comment? Was this project so important when the PLA was heaped upon contractors a mere 16 days before bids were due?

In the end, this project (with the PLA) is over \$780,000 more expensive than last year, had one qualified bidder, excludes 77% of the construction workforce that chooses not to affiliate with a union, and has been executed and imposed under a cloud of secrecy.

This all begs the question: Is it really *this* project that is too important that it cannot be delayed a few weeks in order to be rebid without the PLA, or, rather is it really the imposition of the union-only PLA that is too important?

WHEREAS, the County Executive/Office of Procurement and Diversity has recommended an award on RQ24643 to Cleveland Communications, Inc. in the amount of \$1,204,191.88 for the purchase of 56 Harris Unity Mobile and 190 Portable Multi-Band Radios and accessories for the County Sheriff's Office; and

WHEREAS, the primary goal of this project is to purchase the mobile and portable radios necessary to become compliant with the Federal Communications Commission's ("FCC") Narrow Banding Regulations. Thus, the system must be in place by 1/01/2013; and

WHEREAS, this system will allow the Sheriff's Office to communicate with law enforcement agencies on a local, state and federal level on every available frequency for complete interoperability; and

WHEREAS, the procurement method for this project was a Government Cooperative Purchasing Agreement through the Fire Rescue GPO; and

WHEREAS, the proposed award recommendation received an exemption approval on 8/13/2012, CPB2012-732; and

WHEREAS, this project is funded 100% by the General Fund and is a Capital Project. The schedule of payments is by invoice.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CUYAHOGA COUNTY, OHIO:

SECTION 1. The County Council hereby authorizes an award on RQ24643 to Cleveland Communications, Inc. in the amount of \$1,204,191.88 for the purchase of 56 Harris Unity Mobile and 190 Portable Multi-Band Radios and accessories for the County Sheriff's Office.

SECTION 2. The County Executive is hereby authorized to execute the contract and all other documents consistent with this award and Resolution.

SECTION 3. It is found and determined that all formal actions of this Council relating to the adoption of this Resolution were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
