1. CALL TO ORDER

Chairman Gallagher called the meeting to order at 11:03 a.m.

2. ROLL CALL

- a) R2012-0198: A Resolution making an award on RQ24643 to Cleveland Communications, Inc. in the amount of \$1,204,191.88 for the purchase of 56 Harris Unity Mobile and 190 Portable Multi-Band Radios and accessories for the County Sheriff's Office; authorizing the County Executive to execute the

contract and all other documents consistent with said award and this Resolution.
