1. CALL TO ORDER

Chairman Miller called the meeting to order at 1:02 p.m.

2. ROLL CALL

Mr. Miller asked Assistant Deputy Clerk Carter to call the roll. Committee members Miller, Gallagher, Jones, Connally, Greenspan and Brady were in attendance and a quorum was determined. Committee member Schron was absent from the meeting.

A motion was then made by Mr. Gallagher, seconded by Mr. Brady and approved by unanimous vote to excuse Mr. Schron from the meeting.

3. PUBLIC COMMENT RELATED TO THE AGENDA

No public comments were given.

4. APPROVAL OF MINUTES FROM THE MARCH 4, 2013 MEETING

A motion was made by Ms. Connally, seconded by Mr. Jones and approved by unanimous vote to approve the minutes of the March 4, 2013 meeting.

- 5. MATTERS REFERRED TO COMMITTEE
 - a) <u>R2013-0046</u>: A Resolution amending Resolution No. R2012-0076, which governed the County's acceptance and use of funds from the Soldiers' and Sailors' Monument Support Group.

Mr. Trevor McAleer, Legislative Budget Advisor and Mr. Kahlil Seren, Research and Policy Analyst, addressed the Committee regarding Resolution No. R2013-0046. Discussion ensued.

Committee members asked questions of Mr. McAleer and Mr. Seren pertaining to the item, which they answered accordingly.

A motion was then made by Mr. Miller, seconded by Ms. Connally and approved by unanimous vote to amend Resolution No. R2013-0046 as follows:

"SECTION 1. The Cuyahoga County Council hereby amends Resolution No. R2012-0076 to add new Sections 4 and 5 to read as follows:"

"SECTION 5. The Soldiers' and Sailors' Monument Support Group shall transfer the funds to Cuyahoga County no later than July 31, 2013."

On a motion by Ms. Connally with a second by Mr. Jones, Resolution No. R2013-0046 was considered and approved by unanimous vote to be referred to the full Council agenda with a recommendation for passage under second reading suspension of the rules, as amended.
