#### 1. CALL TO ORDER

Chairman Miller called the meeting to order at 1:06 p.m.

## 2. ROLL CALL

Mr. Miller asked Assistant Deputy Clerk Carter to call the roll. Committee members Miller, Gallagher, Schron and Brady were in attendance and a quorum was determined. Committee members Jones and Greenspan were absent from the meeting. Committee member Connally entered the meeting shortly after the roll call was taken. Councilmember Conwell was also in attendance.

A motion was then made by Mr. Schron, seconded by Mr. Gallagher and approved by unanimous vote to excuse Mr. Jones and Mr. Greenspan from the meeting.
