

## MINUTES

## CUYAHOGA COUNTY HEALTH, HUMAN SERVICES & AGING COMMITTEE MEETING WEDNESDAY, JANUARY 30, 2013 CUYAHOGA COUNTY JUSTICE CENTER COUNCIL CHAMBERS – 1<sup>ST</sup> FLOOR 1:00 PM

1. CALL TO ORDER

Chairman Brady called the meeting to order at 1:01 p.m.

2. ROLL CALL

Chairman Brady asked Deputy Clerk Muller to call the roll. Committee members Brady, Conwell, Greenspan and Miller were in attendance and a quorum was determined. Committee member Jones entered the meeting shortly after the roll call was taken. Councilmember Rogers was also in attendance.

3. PUBLIC COMMENT RELATED TO THE AGENDA

No public comments related to the agenda were given.

4. APPROVAL OF MINUTES FROM JANUARY 17, 2013 MEETING

A motion was made by Ms. Conwell, seconded by Mr. Brady and approved by unanimous vote to approve the minutes of the January 17, 2013 meeting.

- 5. MATTERS REFERRED TO COMMITTEE
  - a) <u>R2013-0018</u>: A Resolution making an award on RQ22383 to MHS, Inc. in the amount not-to-exceed \$1,148,293.00 for emergency shelter services for homeless women and families, located at 2227 Payne Avenue, Cleveland, for the period 1/1/2013 12/31/2013; authorizing the County Executive to execute the contract and all other documents consistent with said award and this Resolution; and declaring the necessity that this Resolution become immediately effective.

Ms. Shari Weir, Program Officer at the Office of Homeless Services, addressed the Committee regarding Resolution No. R2013-0018. Discussion ensued.

Committee members and Councilmembers asked questions of Ms. Weir pertaining to the item, which she answered accordingly.

On a motion by Mr. Brady with a second by Mr. Miller, Resolution No. R2013-0018 was considered and approved by unanimous vote to be referred to the full Council agenda with a recommendation for passage under second reading suspension of rules.

 b) <u>R2013-0019</u>: A Resolution making an award on RQ22383 to Lutheran Metropolitan Ministry in the amount of \$1,654,920.00 for emergency shelter services for homeless men, located at 2100 Lakeside Avenue, Cleveland, for the period 1/1/2013 - 12/31/2013; authorizing the County Executive to execute the contract and all other documents consistent with said award and this Resolution; and declaring the necessity that this Resolution become immediately effective.

Ms. Weir addressed the Committee regarding Resolution No. R2013-0019. Discussion ensued.

Committee members and Councilmembers asked questions of Ms. Weir pertaining to the item, which she answered accordingly.

On a motion by Mr. Brady with a second by Mr. Miller, Resolution No. R2013-0019 was considered and approved by unanimous vote to be referred to the full Council agenda with a recommendation for passage under second reading suspension of rules.

- c) <u>R2013-0020</u>: A Resolution making awards on RQ25318 to various providers in the total amount not-to-exceed \$2,400,000.00 for child and family-focused services for the period 2/1/2013 1/31/2015, and authorizing the County Executive to execute the contracts and all other documents consistent with said awards and this Resolution:
  - 1) Applewood Centers, Inc. in the amount not-to-exceed \$240,000.00.
  - 2) The Bair Foundation in the amount not-to-exceed \$150,000.00.
  - 3) Beech Brook in the amount not-to-exceed \$278,570.00.
  - 4) Bellefaire Jewish Children's Bureau in the amount not-to-exceed \$278,570.00.
  - 5) Catholic Charities Corporation fka Catholic Charities Services Corporation in the amount not-to-exceed \$278,570.00.
  - 6) Centers for Families and Children in the amount not-to-exceed \$278,570.00.
  - 7) The Cleveland Christian Home, Incorporated in the amount notto-exceed \$278,570.00.
  - 8) Guidestone in the amount not-to-exceed \$278,570.00.

- 9) Mental Health Services for Homeless Persons, Inc. in the amount not-to-exceed \$188,580.00.
- 10) Specialized Alternatives for Families and Youth of Ohio, Inc. in the amount not-to-exceed \$150,000.00.

Ms. Karen Stormman and Mr. Raymond James, representing the Department of Children and Family Services; Mr. Rick Werner, Director of Health and Human Services; and Mr. David Merriman, Interim Deputy Chief of Staff for Health and Human Services, addressed the Committee regarding Resolution No. R2013-0020. Discussion ensued.

Committee members and Councilmembers asked questions of Ms. Stormman, Mr. James, Mr. Werner and Mr. Merriman pertaining to the item, which they answered accordingly.

On a motion by Mr. Jones with a second by Mr. Miller, Resolution No. R2013-0020 was considered and approved by unanimous vote to be referred to the full Council agenda with a recommendation for passage under second reading suspension of rules.

d) <u>O2013-0004</u>: An Ordinance amending Ordinance No. O2011-0045, as amended, which established divisions and sections within the Department of Health and Human Services, to create the Office of the Director and to delineate displacement, reinstatement and reemployment procedures; and declaring the necessity that this Ordinance become immediately effective.

Mr. Werner, Mr. Merriman, and Mr. Joseph Gauntner, Director of Job and Family Services, addressed the Committee regarding Ordinance No. O2013-0004. Discussion ensued.

Committee members and Councilmembers asked questions of Mr. Werner, Mr. Merriman and Mr. Gauntner pertaining to the item, which they answered accordingly.

No legislative action was taken on Ordinance No. O2013-0004 at this time.
