WHEREAS, the County Executive/Department of Health and Human Services/Division of Community Initiatives/Office of Re-entry has recommended awards on various Requisitions to various providers in the total amount of \$729,993.00 for comprehensive case management, direct services and referral services for the FY2012 Second Chance Act Adult Offender Reentry Program for the period 10/1/2012 - 9/30/2013 for the following:

- 1) RQ27042 to Case Western Reserve University, Begun Center for Violence Prevention, Research and Education in the amount of \$75,000.00;
- 2) RQ25135 to The Centers for Families and Children in the amount of \$50,400.00;
- 3) RQ27037 to Community Assessment and Treatment Services, Inc. in the amount of \$312,398.00;

WHEREAS, the primary goals of the project are to provide comprehensive case management, direct services and referral services to approximately 150 clients returning to Cuyahoga County from incarceration in local prisons, and to provide an evaluation to analyze data markers including: demographic, descriptive, and recruitment date by site results; and,

WHEREAS, the project is federally funded 100% by FY2012 Second Chance Act Adult Offender Reentry grant funds; and,

WHEREAS, it is necessary that this Resolution become immediately effective in order that critical services provided by Cuyahoga County can continue and to provide for the usual, daily operation of a County entity.

# NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CUYAHOGA COUNTY, OHIO:

**SECTION 1.** That the Cuyahoga County Council hereby makes awards on various Requisitions to various providers in the total amount of \$729,993.00 for comprehensive case management, direct services and referral services for the FY2012 Second Chance Act Adult Offender Reentry Program for the period 10/1/2012 - 9/30/2013 for the following:

- 1) RQ27042 to Case Western Reserve University, Begun Center for Violence Prevention, Research and Education in the amount of \$75,000.00;
- 2) RQ25135 to The Centers for Families and Children in the amount of \$50,400.00;
- 3) RQ27037 to Community Assessment and Treatment Services, Inc. in the amount of \$312,398.00; and,
- 4) RQ27035 to Community Re-entry Inc. in the amount of \$292,195.00.

**SECTION 2.** That the County Executive is authorized to execute contracts in connection with said awards and all documents consistent with this Resolution.

**SECTION 3.** It is necessary that this Resolution become immediately effective for the usual daily operation of the County and the reasons set forth in the preamble. Provided that this Resolution receives the affirmative vote of at least eight members of Council, it shall take effect and be in force immediately upon the earliest occurrence of any of the following: (1) its approval by the County Executive through signature, (2) the expiration of the time during which it may be disapproved by the County Executive under Section 3.10(6) of the Cuyahoga County Charter, or (3) its passage by at least eight members of Council after disapproval pursuant to Section 3.10(7) of the Cuyahoga County Charter. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

**SECTION 4.** It is found and determined that all formal actions of this Council relating to the adoption of this Resolution were adopted in an open meeting of the Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

WHEREAS, this project is funded 100% from the Health & Human Services levy; and,
