1. CALL TO ORDER

Chairman Rogers called the meeting to order at 3:11 p.m.

2. ROLL CALL

Mr. Rogers asked Assistant Deputy Clerk Carter to call the roll. Committee members Rogers, Germana and Schron were in attendance and a quorum was determined. Committee member Simon entered the meeting shortly after the roll call was taken. Committee member Connally was absent from the meeting. Councilmember Miller was also in attendance.

3. PUBLIC COMMENT RELATED TO THE AGENDA

No public comments were given.

4. APPROVAL OF MINUTES FROM THE APRIL 17, 2013 MEETING

A motion was made by Mr. Germana, seconded by Mr. Schron and approved by unanimous vote to approve the minutes of the April 17, 2013 meeting.

- MATTERS REFERRED TO COMMITTEE
  - a) R2013-0087: A Resolution making an award to College Now Greater Cleveland in the amount of \$115,000.00 from the Cuyahoga County Educational Assistance Fund for Component 2 of the Cuyahoga County Educational Assistance Program for the period ending 6/30/2014; authorizing the County Executive to execute the contract and all other documents consistent with said award and this Resolution; and

declaring the necessity that this Resolution become immediately effective.

Sr. Joanne Gross, Senior Policy Advisor, addressed the Committee regarding Resolution No. R2013-0087. Discussion ensued.

Committee members and Councilmembers asked questions of Sr. Gross pertaining to the item, which she answered accordingly.

On a motion by Mr. Schron with a second by Ms. Simon, Resolution No. R2013-0087 was considered and approved by unanimous vote to be referred to the full Council agenda for second reading.

b) <u>O2013-0011:</u> An Ordinance amending Ordinance No. O2012-0007 dated 7/10/2012, which established the Cuyahoga County Educational Assistance Program and the Cuyahoga County Educational Assistance Fund, to add additional components to the Program and to authorize an alternative procurement process; creating Chapter 710 and Section 804.01 to codify said Program and Fund; and declaring the necessity that this Ordinance become immediately effective.

Mr. Rogers addressed the Committee regarding Ordinance No. 02013-0011. Discussion ensued.

Sr. Gross; Ms. Lee Friedman, Chief Executive Officer of College Now Greater Cleveland; and Mr. Robert Durham, Director of Scholarship Services and Financial Aid of College Now Greater Cleveland, addressed the Committee regarding Ordinance No. O2013-0011. Discussion ensued.

Committee members and Councilmembers asked questions of Sr. Gross, Ms. Friedman and Mr. Durham pertaining to the item, which they answered accordingly.

A motion was then made by Mr. Schron, seconded by Mr. Germana and approved by unanimous vote to amend Ordinance No. O2013-0011 by inserting "at institutions located within Cuyahoga County" in Section 804.01(C)(1).

A motion was made by Mr. Rogers, seconded by Mr. Germana and approved by unanimous vote to amend Ordinance No. O2013-0011 by inserting "two or" in Section 804.01(C)(4)(d).

On a motion by Mr. Schron with a second by Mr. Germana, Ordinance No. R2013-0011 was considered and approved by unanimous vote to be referred to the full Council agenda for second reading, as amended.
