1. CALL TO ORDER

Chairman Rogers called the meeting to order at 3:00 p.m.

WHEREAS, the Department of Public Works' Rules and Regulations currently discourage ride sharing by limiting the use of parking passes to one employee; and

WHEREAS, the County substantially subsidizes the cost of employee parking at the Huntington Park Garage; and

WHEREAS, the County minimally subsidizes the cost of employee public transit passes; and

WHEREAS, Municipalities, Counties, and States throughout the Country subsidize public transportation for employees; and

WHEREAS, the Federal Government wholly subsidizes the cost of public transportation for employees; and

WHEREAS, free resources are available that facilitate individuals searching for others with whom to ride share; and

WHEREAS, Section 7.10 of the Cuyahoga County Human Resources Personnel Policies and Procedures Manual, last approved by Council Ordinance No. O2013-0003, states that the County encourages all employees to seek opportunities to incorporate sustainable principles in work and home life, including using public transportation and fuel efficient vehicles; and

WHEREAS, it is necessary that this Resolution become immediately effective in order to maximize the economic and environmental benefits of improved transportation and parking policies and in order that critical services provided by Cuyahoga County can continue and to provide for the usual, daily operation of County departments, offices, and agencies.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CUYAHOGA COUNTY, OHIO:

**SECTION 1.** That the County Executive, acting through the appropriate department(s), propose transportation policies and procedures that include, at a minimum, the following:

- A public transportation subsidy of a percentage at least equal to the subsidy currently provided to employees parking at the Huntington Park Garage; and,
- b) A program whereby employee contributions to public transportation costs are paid with pre-tax dollars; and,
- c) Encouragement for employees to carpool/ride share.

**SECTION 2.** That the County Executive shall provide Council with the above-outlined proposal not later than sixty (60) days from the effective date of this Resolution.

**SECTION 3.** It is necessary that this Resolution become immediately effective for the usual daily operation of the County; the preservation of public peace, health, or safety in the County; and any additional reasons set forth in the preamble. Provided that this Resolution receives the affirmative vote of at least eight members of Council, it shall take effect and be in force immediately upon the earliest occurrence of any of the following: (1) its approval by the County Executive through signature, (2) the expiration of the time during which it may be disapproved by the County Executive under Section 3.10(6) of the Cuyahoga County Charter, or (3) its passage by at least eight members of Council after disapproval pursuant to Section 3.10(7) of the Cuyahoga County Charter. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

**SECTION 4.** It is found and determined that all formal actions of this Council relating to the adoption of this Resolution were adopted in an open meeting of the Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

WHEREAS, the County Executive FitzGerald/Department of Workforce Development, in partnership with City of Cleveland/Cuyahoga County Workforce Investment Board, in partnership with the City of Cleveland/Cuyahoga County Workforce Board, has recommended making awards on RQ26661 in the total amount not-to-exceed \$2,641,737.00 for Employment Connection One-Stop Operation and Services to Job Seekers for the period 7/1/2013 - 6/30/2014 to the following training providers:

- 1) Mature Services, Incorporated in the amount not-to-exceed \$262,237.00,
- 2) United Labor Agency, Inc. (ULA) in the amount not-to-exceed \$2,379,500.00; and

WHEREAS, these services are necessary to offer employment connection services mandated by the Federal Workforce Investment Act (WIA) to adults and dislocated worker job seekers; and

WHEREAS, this project is funded as follows: (a) ULA will receive 81% of its funding from WIA and 19% from TANF funds; and (b) Mature Services will receive 53% of its funding from WIA, and 47% from TANF funds; and,

WHEREAS, it is necessary that this Resolution become immediately effective in order that critical services provided by Cuyahoga County can continue and to provide for the usual, daily operation of a County entity.

# NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CUYAHOGA COUNTY, OHIO:
