1. CALL TO ORDER

Chairman Greenspan called the meeting to order at 9:13 a.m.

2. ROLL CALL

Mr. Greenspan asked Assistant Deputy Clerk Carter to call the roll. Committee members Greenspan, Miller, Brady, Gallagher and Connally were in attendance and a quorum was determined.

3. PUBLIC COMMENT RELATED TO THE AGENDA

No public comments were given.

4. APPROVAL OF MINUTES FROM THE APRIL 1, 2013 MEETING

A motion was made by Mr. Brady, seconded by Mr. Gallagher and approved by unanimous vote to approve the minutes of the April 1, 2013 meeting.

- 5. MATTERS REFERRED TO COMMITTEE
 - a) Old Business
 - <u>O2013-0002</u>: An Ordinance amending the Public Records Policy for Cuyahoga County, and declaring the necessity that this Ordinance become immediately effective.

Mr. Miller introduced a proposed substitute to Ordinance No. O2013-0002. Discussion ensued.

Ms. Nora Hurley, Deputy Chief Director of Law; Mr. Daniel Humphrey, Program Officer; Mr. Michael King, Assistant Law Director; Mr. Ed Morales, Assistant Law Director; and Ms. Jeanne Schmotzer, Clerk of Council, addressed the Committee regarding Ordinance No. O2013-0002. Discussion ensued.

Committee members asked questions of Ms. Hurley, Mr. Humphrey, Mr. King, Mr. Morales and Ms. Schmotzer pertaining to the item, which they answered accordingly.

A motion was made by Mr. Miller, seconded by Mr. Brady and approved by unanimous vote to accept the proposed substitute.

A motion was then made by Mr. Greenspan, seconded by Mr. Miller and approved by unanimous vote to amend Ordinance No. O2013-0002 by deleting "an appropriate" and inserting "his or her" in Section 106.04(B).

A motion was made by Mr. Greenspan, seconded by Mr. Brady and approved by unanimous vote to amend Ordinance No. O2013-0002 by deleting "office" in Section 106.05(D).

A motion was then made by Mr. Miller, seconded by Ms. Connally and approved by unanimous vote to amend Ordinance No. O2013-0002 by deleting "Economic" in Section 106.05(E)(2)(g).

A motion was made by Mr. Miller, seconded by Ms. Connally and approved by unanimous vote to amend Ordinance No. O2013-0002 by inserting "(v) the County Treasurer" and "(w) the County Prosecutor" after Section 106.05(E)(2)(u).

A motion was then made by Mr. Greenspan, seconded by Ms. Connally and approved by unanimous vote to amend Ordinance No. O2013-0002 by *deleting* "Office" *and inserting* "Officer" *in Section 106.05(E)(2)(I); and inserting* "the" in Section 106.05(E)(2)(m).

A motion was made by Ms. Connally, seconded by Ms. Miller and approved by unanimous vote to amend Ordinance No. O2013-0002 by inserting "unless otherwise addressed in Section 106.07(B)" in Section 106.07(A).

A motion was then made by Ms. Connally, seconded by Mr. Miller and approved by unanimous vote to amend Ordinance No. O2013-0002 by deleting "as follows" and inserting "and Chapter 306 of the Cuyahoga County Code is hereby amended to read as follows:" in Section 1.

On a motion by Mr. Miller with a second by Ms. Connally, Ordinance No. O2013-0002 was considered and approved by unanimous vote to be referred to the full Council agenda for second reading, as substituted and amended.
