Pursuant to Section 3375.22 of the Ohio Revised Code, I submit the following nominee for appointment to the Cuyahoga County Public Library Board of Trustees:

Dean E. DePiero

The System serves 47 communities. Its mission is to be at the center of community life by creating an environment where reading, lifelong learning and civic engagement thrive. Functionally, the Board governs the Library's overall operations.

The Board is comprised of seven members. Four members are appointed by the County Executive, and three members are appointed by the judges of the Court of Common Pleas. Ohio Revised Code requires that Board members be qualified electors of the library district. Mr. DePiero is a resident of Strongsville. As shown in the attached biography, he has great depth of experience in public administration, having served as a State Representative in the Ohio Legislature and as Mayor of the City of Parma. He currently works as an attorney for McDonald Hopkins' public finance practice, and is Law Director for the City of Aurora and Assistant Law Director/Prosecutor for the City of Broadview Heights.

He is active in the community, currently serving as a board member for the University Hospitals - Parma Hospital Health Care Foundation, the Strongsville Education Foundation Board, and as a member of the Mt. Alverna Village Advisory Committee.

The length of term for each member is seven years, and the position is uncompensated. Mr. DePiero will replace outgoing Board member Susan Adams, with a term that runs from February 1, 2017 through January 31, 2024.

Title: Department of Human Resources 2017 CaremarkPCS Health, L.L.C. amendment for group healthcare benefits

A. Scope of Work Summary

Department of Human Resources requesting approval of a contract amendment with CaremarkPCS Health, L.L.C. for the anticipated cost not-to-exceed \$17,662,807.67. The associated start and completion dates for the contract are 01/01/2015- 12/31/2017. The primary goal of the contract and amendment is to provide group healthcare benefits to County employees and their eligible dependents, and Regionalized Benefits Partners and their eligible dependents.

B. Procurement

The procurement method for was formal Request for Proposals (#30390). Currently, the total value of the CaremarkPCS Health, L.L.C. portion of this RFP is \$42,989,733. This amendment is for an additional \$17,662,807.67.

The RFP was closed on 5/21/2014. It included an SBE participation goal of 3%. There were seven vendor proposals submitted for review, and three proposals approved.

C. Contractor and Project Information

D. Project Status and Planning

This contract is ongoing through 12/31/2017.

The amendment is on a critical action path because some funds requested are due to the vendor.

The reason there was a delay in this request is the Department's desire to be as accurate as possible with this request. Therefore, the Department waited until 2017 benefits open enrollment was completely closed and all information from open enrollment could be calculated.

E. Funding

This amendment will be funded 72.8% by the Self Insurance Fund (HR499061-0278) and 27.2% by a Special Revenue Fund (Regional Benefits Fund) (HR499087-0278). The schedule of payments is by invoice.

This is an amendment to a contract. This amendment changes the value and is the 2^{nd} amendment of the contract. The previous amendment was for \$2,800,000 passed to include Regionalized Benefits Partners on 12/8/2015.

Title: The Department of Human Resources 2017 Medical Mutual Services, L.L.C. amendment for group healthcare benefits

A. Scope of Work Summary

The Department of Human Resources is requesting approval of an amendment with Medical Mutual Services, L.L.C. for the anticipated cost not-to-exceed \$70,232,190.78. This amendment is to a contract dated 01/01/2015- 12/31/2017.

The primary goal of the contract and amendment is to provide group healthcare benefits to County employees and their eligible dependents, and Regionalized Benefits Partners and their eligible dependents.

B. Procurement

The procurement method for the contract was formal Request for Proposal (#30390). Currently, the total value of the Medical Mutual of Ohio portion of this RFP is \$141,636,022. This amendment is for an additional \$70,232,190.78 The RFP was closed on May 21, 2014. There was an SBE participation/goal of 3%. There were seven vendor proposals submitted for review, and 3 proposals approved.

C. Contractor and Project Information
