## 1. CALL TO ORDER

Vice-Chairwoman Brown called the meeting to order at 3:01 p.m.

## 2. ROLL CALL

Ms. Brown asked Deputy Clerk Carter to call the roll. Committee members Brown, Jones, and Schron were in attendance and a quorum was determined. Committee members Simon and Brady were absent from the meeting. Councilmember Miller was also in attendance.

4. APPROVAL OF MINUTES FROM THE MAY 31, 2017 MEETING

A motion was made by Mr. Jones, seconded by Mr. Schron and approved by unanimous vote to approve the minutes from the May 31, 2017 meeting.

  - a) <u>R2017-0163</u>: A Resolution authorizing amendments to contracts with various providers for various services in connection with the Workforce Innovation and Opportunity Act for the period 7/1/2016 6/30/2017 to extend the time period

to 6/30/2018 and for additional funds; authorizing the County Executive to execute the amendments and all other documents consistent with this Resolution; and declaring the necessity that this Resolution become immediately effective:
