1. CALL TO ORDER

Chairwoman Conwell called the meeting to order at 1:10 p.m.

2. ROLL CALL

Ms. Conwell asked Assistant Deputy Clerk Johnson to call the roll. Committee members Conwell, Houser, Baker, Brown and Miller were in attendance and a quorum was determined.

3. PUBLIC COMMENT RELATED TO THE AGENDA

Ms. Rhonda Hills and Ms. Donna Walker-Brown addressed the Committee regarding Resolution No. R2018-0063, A resolution making awards on RQ40883 to various providers for community-based services to support at-risk children and families in Cuyahoga County for the period 4/1/2018 - 3/31/2019.

4. APPROVAL OF MINUTES FROM THE MARCH 21, 2018 MEETING

A motion was made by Ms. Brown, seconded by Ms. Baker and approved by unanimous vote to approve the minutes of the March 21, 2018 meeting.

- viii. University Settlement in the amount not-to-exceed \$380,000.00.
- ix. West Side Community House in the amount not-to-exceed \$450,000.00.
