1. CALL TO ORDER

Chairwoman Conwell called the meeting to order at 1:05 p.m.

 - R2018-0195: A Resolution authorizing an amendment to Contract No. CE1700023-01 with Lutheran Metropolitan Ministry for Adult Guardianship Services for the period 1/1/2017 12/31/2018 to extend the time period to 12/31/2019 and for additional funds in the amount not-to-exceed \$553,000.00; authorizing the County Executive to execute the amendment and all other documents consistent with this Resolution; and declaring the necessity that this Resolution become immediately effective.

Mr. Paul Porter, Procurement and Contractual Services Administrator for the Division of Senior and Adult Services; Ms. Marlene Robinson- Statler, Interim Director for the Department of Senior and Adult Services; Ms. Kendra Daniel, Director of Adult Support & Advocacy for Lutheran Metropolitan Ministries; Ms. Wendy Feinn, Budget & Management Analyst; and Mr. Robert Math, Administrator for the Division of Contract Administration and Performance, addressed the Committee regarding Resolution No. R2018-0195.
