#### 1. CALL TO ORDER

  - a) R2018-0166: A Resolution making an award on RQ42329 to Neighborhood Housing Services of Greater Cleveland, Inc. in the

amount not-to-exceed \$526,188.17 for administration of the Cuyahoga County Down Payment Assistance Program in Cuyahoga Urban County Communities and City of Parma for the period 4/1/2018 - 9/30/2019; authorizing the County Executive to execute the contract and all other documents consistent with said award and this Resolution; and declaring the necessity that this Resolution become immediately effective.

Mr. Kenneth Surrat, Deputy Director of Housing and Community Development; and Mr. Michael Cosgrove, Executive Director of Neighborhood Housing Services of Greater Cleveland, addressed the Committee regarding Resolution No. R2018-0166. Discussion ensued.

Committee members asked questions of Messrs. Surrat and Cosgrove pertaining to the item, which they answered accordingly.

On a motion by Mr. Jones with a second by Mr. Brady, Resolution No. R2018-0166 was considered and approved by unanimous vote to be referred to the full Council agenda with a recommendation for passage under second reading suspension of the rules.

WHEREAS, the County Council desires to provide a Community Development Fund grant, which is funded from Casino Revenue, in the amount of \$150,000.00 to Cleveland Cultural Gardens Federation for the benefit of the Centennial Peace Plaza Project, located in Rockefeller Park in the City of Cleveland; and

WHEREAS, the Cuyahoga County Code Section 709.02(A) states that funds in the Community Development Fund may be used to "promote economic and community development in any area of Cuyahoga County;" and

WHEREAS, the Cleveland Cultural Gardens Federation has created a plan for construction of the Centennial Peace Plaza with a total estimated project cost of \$971,225.00; and

WHEREAS, the primary goal of this project is to contribute to the enhancement of a municipally-owned community amenity in collaboration with a private, nonprofit partner; and

WHEREAS, the project will be funded from the Community Development Fund, which is funded from Casino Revenue, and is located in County Council District 7; and

# NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CUYAHOGA COUNTY, OHIO:

**SECTION 1.** That the Cuyahoga County Council hereby authorizes a Community Development Fund grant in the amount of \$150,000.00 to Cleveland Cultural Gardens Federation for the benefit of the Centennial Peace Plaza Project, located in Rockefeller Park in the City of Cleveland.

**SECTION 2.** That the release of funds from the Community Development Fund grant authorized by this Resolution shall be contingent on the Cleveland Cultural Gardens Federation securing all other funding necessary to complete the Centennial Peace Plaza Project.

**SECTION 3.** That County Council staff is authorized to prepare all documents to effectuate said grant.

**SECTION 4.** That the County Executive is authorized to execute all necessary agreements and documents consistent with said grant and this Resolution.

**SECTION 5.** This Resolution shall sunset twelve (12) months after County Council approval should the authorized action have not occurred by that date. In the event this Resolution sunsets prior to the authorized action taking place, the Clerk of Council shall be notified in writing. The Clerk of Council shall record the sunsetting of this Resolution in the Council's journal.

**SECTION 6.** It is found and determined that all formal actions of this Council relating to the adoption of this Resolution were adopted in an open meeting of the Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
