His background is business leadership. He became the second generation and leader and owner of his family trucking firm, growing the company from \$3M to \$35M in revenues while creating distribution and logistics services related entities. Since 2013 he has served in multiple roles. Senior Vice President and Executive Director of The Greater Cleveland Partnership's Commission on Economic Inclusion as well as Owner/CEO of JIT Services LLC, and The League Development Co Inc.
