1. CALL TO ORDER

Chairman Gallagher called the meeting to order at 1:06 p.m.

2. ROLL CALL

Mr. Gallagher asked Deputy Clerk Carter to call the roll. Committee members Gallagher, Baker, Tuma, Brady and Conwell were in attendance and a quorum was determined. Councilmember Miller was also in attendance.

3. PUBLIC COMMENT

There were no public comments given.

4. APPROVAL OF MINUTES FROM THE APRIL 16, 2019 MEETING

A motion was made by Ms. Conwell, seconded by Ms. Baker and approved by unanimous vote to approve the minutes from the April 16, 2019 meeting.

 - a) O2019-0007: An Ordinance amending Section 402.01(L) of the Cuyahoga County Code to modify the definition of "relative" as it is used in the County's code of ethics, and declaring the necessity that this Ordinance become immediately effective.

Ms. Brandy Carney, Chief Community Protection and Safety Officer, addressed the Committee regarding Ordinance No. O2019-0007. Discussion ensued.

b) Solitary confinement at County Jail

Ms. Carney addressed the Committee regarding medical staffing levels, bail reform and pretrial services. Discussion ensued.
