### 1. CALL TO ORDER

4. APPROVAL OF MINUTES FROM THE FEBRUARY 16, 2021 MEETING

A motion was made by Mr. Tuma, seconded by Ms. Conwell and approved by unanimous vote to approve the minutes from the February 16, 2021 meeting.

# 5. MATTERS REFERRED TO COMMITTEE

a) R2021-0057: A Resolution making an award on RQ2911 to Mental Health Services for Homeless Persons, Inc. dba FrontLine Service in the amount not-to-exceed \$868,300.00 for Children Who Witness Violence Services for the period 2/1/2021 - 1/31/2023; authorizing the County Executive to execute Contract No. 742 and all other documents

consistent with said award and this Resolution; and declaring the necessity that this Resolution become immediately effective.

Mr. Alex Pellom, Director of the Department of Public Safety & Justice Services; and Ms. Jill Smialek, Manager of Witness Victim Services, addressed the Committee regarding Resolution No. R2021-0057. Discussion ensued.

Committee members and Councilmembers asked questions of Mr. Pellom and Ms. Smialek pertaining to the item, which they answered accordingly.

On a motion by Ms. Conwell with a second by Mr. Jones, Resolution No. R2021-0057 was considered and approved by unanimous vote to be referred to the full Council agenda with a recommendation for passage under second reading suspension of the rules.

b) R2021-0058: A Resolution making an award on RQ3186 and enter into a Membership Participation Agreement with Chagrin Valley Dispatch Council in the amount not-to-exceed \$1,521,475.00 for dispatch operation services for law enforcement activities for the period 4/28/2021 – 12/31/2022; authorizing the County Executive to execute Agreement No. 512 and all other documents consistent with this Resolution; and declaring the necessity that this Resolution become immediately effective.

Mr. Stephen Witt, Fiscal Specialist; Capt. Donald Gerome, Deputy Sheriff; and Ms. Brandy Carney, Chief of Special Operations, addressed the Committee regarding Resolution No. R2021-0058. Discussion ensued.

Committee members and Councilmembers asked questions of Mr. Witt, Capt. Gerome and Ms. Carney pertaining to the item, which they answered accordingly.

On a motion by Ms. Simon with a second by Mr. Tuma, Resolution No. R2021-0058 was considered and approved by unanimous vote to be referred to the full Council agenda with a recommendation for passage under second reading suspension of the rules.
