1. CALL TO ORDER

Chairwoman Stephens called the meeting to order at 10:02 a.m.

2. ROLL CALL

Ms. Stephens asked Assistant Deputy Clerk Johnson to call the roll. Committee members Stephens, Jones, Gallagher, and Baker were in attendance and a quorum was determined. Committee member Simon joined the meeting after the roll call was taken. Councilmember Tuma was also in attendance.

3. PUBLIC COMMENT

Mr. Lee Weingart addressed the Committee regarding Resolution No. R2022-0153, a Resolution awarding a total sum, not to exceed \$4,000,000 to the City of Parma for the purpose of constructing the Ridgewood Golf Course Clubhouse & Event Center from the District 4 ARPA Community Grant Fund, R2022-0156, a Resolution awarding a total sum, not to exceed \$3,500,000 to the City of Strongsville for the purpose of the Strongsville Town Center Enhancement & Walkability Initiative from the District 5, and Resolution No. R2022-0157, a Resolution awarding a total sum, not to exceed \$1,000,000 to the City of North Royalton for the purpose of the Memorial Park Improvement Project from the District 5 ARPA Community Grant Fund.

Loh addressed the Committee regarding Resolution No R2022-0172, a Resolution authorizing a contract with Frank Ford Consulting, LLC in the total amount not to exceed \$39,000 for the provision of Mortgage Lending Research and Technical Assistance to Cuyahoga County.

b) R2022-0186: A Resolution authorizing a grant award to Cuyahoga Arts & Culture in the amount not-to-exceed \$1,650,000.00 to provide support to arts and culture mission-based, non-profit organizations in Cuyahoga County, commencing upon contract signature of all parties for a period of 1 year; authorizing the County Executive to execute Contract No. 2414 and all other documents consistent with said award and this Resolution; and declaring the necessity that this Resolution become immediately effective.

Mr. Paul Herdeg, Director of the Department of Development, and Ms. Jill Paulsen, Executive Director of Cuyahoga Arts & Culture, addressed the Committee regarding Resolution No. R2022-0186. Discussion ensued.

d) R2022-0188: A Resolution authorizing a grant award to The Cuyahoga County Land Reutilization Corporation in the amount not-to-exceed \$2,000,000.00 to match funds with Ohio Department of Development for the demolition of vacant and distressed properties in suburban Cuyahoga County communities; commencing upon contract signature of all parties for a period of 3 years; authorizing the County Executive to execute Contract No. 2416 and all other documents consistent with said

award and this Resolution; and declaring the necessity that this Resolution become immediately effective.

Mr. Herdeg and Ms. Kim Kimlin, Director of Community Stabilization for the Cuyahoga County Land Reutilization Corporation, addressed the Committee regarding Resolution No. R2022-0188. Discussion ensued.

Committee members and Councilmembers asked questions of Mr. Herdeg and Ms. Kimlin pertaining to the item, which they answered accordingly.

WHEREAS, the Cuyahoga County Council desires to provide funding from the District 4 ARPA Community Grant Fund in the amount of \$854,355 to the City of Middleburg Heights for the purpose of completing the Southland District Streetscape Improvement Project; and

WHEREAS, the City of Middleburg Heights estimates approximately 163,736 people live within 5 miles of this Project including approximately 64,810 people who qualify as low to moderate income; and

WHEREAS, the City of Middleburg Heights estimates approximately 105 new jobs will be created with this project with an estimated payroll of \$2,800,000 annually; and

WHEREAS, the City of Middleburg Heights estimates the total cost of the project is \$6,400,000; and

WHEREAS, the City of Middleburg Heights indicates the other funding source(s) for this project includes:

- A. \$1,600,000 from the City's own ARPA allocation,
- B. \$300,000 from the City's 2022 budget,
- C. \$280,000 TLCI Implementation Grant from NOACA with a matching amount of \$70,000 from the City,
- D. Tax Incentive Financing (TIF) agreements with property owners and developers; and

WHEREAS, the City of Middleburg Heights is estimating the start date of the project will be September 1, 2022 and the project will be completed by November 30, 2024; and

WHEREAS, the City of Middleburg Heights requested \$854,355 from the District 4 ARPA Community Grant Fund to complete this project; and

WHEREAS, the Cuyahoga County Council desires to provide funding in the amount of \$854,355 to the City of Middleburg Heights to ensure this project is completed; and

WHEREAS, this Council by a vote of at least eight (8) members determines that it is necessary that this Resolution become immediately effective in order that critical services provided by Cuyahoga County can continue to provide for the usually, daily operations of the County.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CUYAHOGA COUNTY, OHIO:

SECTION 1. That the Cuyahoga County Council hereby awards a not-to-exceed amount of \$854,355 to the City of Middleburg Heights from the General Fund made available by the American Rescue Plan Act revenue replacement provision for the purpose of completing the Southland District Streetscape Improvement Project.

SECTION 2. If any specific appropriation is necessary to effectuate this agreement, the Director of the Office of Budget and Management is authorized to submit the requisite documentation to financial reporting to journalize the appropriation.

SECTION 3. That the County Council staff is authorized to prepare all documents to effectuate said award.

SECTION 4. That the County Executive is authorized to execute all necessary agreements and documents consistent with said award and this Resolution.

SECTION 5. If requested or necessary, the Agency of the Inspector General or Department of Internal Audit is authorized to investigate, audit, or review any part of this award.

SECTION 6. To the extent that any exemptions are necessary under the County Code and contracting procedures, they shall be deemed approved by the adoption of this Resolution.
